3 **SECTION 1. DELAY IN DEADLINES FOR STATE COMPLIANCE**

4 **WITH ELECTION ADMINISTRATION REQUIRE-**
5 **MENTS.**

6 (a) VOTING SYSTEMS STANDARDS.—Section 301(d)
7 of the Help America Vote Act of 2002 (42 U.S.C.

1 15481(d)) is amended by striking “January 1, 2006” and
2 inserting “January 1, 2010”.

3 (b) PROVISIONAL VOTING AND VOTING INFORMA-
4 TION.—Section 302(d) of such Act (42 U.S.C. 15482(d))
5 is amended by striking “January 1, 2004” and inserting
6 “January 1, 2008”.

7 (c) COMPUTERIZED STATEWIDE VOTER REGISTRA-
8 TION LIST; IDENTIFICATION REQUIREMENTS FOR CER-
9 TAIN VOTERS WHO REGISTER BY MAIL.—Section 303(d)
10 of such Act (42 U.S.C. 15483(d)) is amended—

11 (1) by striking “January 1, 2004” each place
12 it appears and inserting “January 1, 2008”;

13 (2) in paragraph (1)(B), by striking “January
14 1, 2006” and inserting “January 1, 2010”; and

15 (3) in paragraph (2)(B), by striking “January
16 1, 2003” and inserting “January 1, 2007”.

17 **SEC. 2. EXTENSION OF AVAILABILITY AND PERIOD OF**
18 **WAIVER OF DEADLINE FOR REPLACEMENT**
19 **OF PUNCH CARD AND LEVER VOTING MA-**
20 **CHINES.**

21 Section 102(a)(3)(B) of the Help America Vote Act
22 of 2002 (42 U.S.C. 15302(a)(3)(B)) is amended—

23 (1) by striking “January 1, 2004,” and insert-
24 ing “January 1, 2008,”; and

1 (2) by striking “January 1, 2006,” and insert-
2 ing “January 1, 2010,”.

3 **SEC. 3. EFFECTIVE DATE.**

4 The amendments made by this Act shall take effect
5 as if included in the enactment of the Help America Vote
6 Act of 2002.
