A BILL

To dedicate 10 percent of Hurricane Katrina disaster relief funds for mental health services to victims and first responders.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Hurricane Katrina
- 5 Mental Health Relief Act of 2005".

1	SEC. 2. DEDICATION OF 10 PERCENT OF HURRICANE
2	KATRINA DISASTER RELIEF FUNDS FOR MEN-
3	TAL HEALTH SERVICES TO VICTIMS AND
4	FIRST RESPONDERS.
5	(a) In General.—Of the amounts provided in any
6	Act for "Disaster Relief" enacted on or after September
7	8, 2005, in response to Hurricane Katrina and its after-
8	math, notwithstanding any other provision of law, 10 per-
9	cent shall be available to the Secretary of Health and
10	Human Services to provide reimbursement without cost-
11	sharing for mental health professionals for the provision
12	of outpatient mental health treatment (including appro-
13	priate prescription medications) of victims of, and first re-
14	sponders to, Hurricane Katrina for the treatment of
15	stress, trauma, and other mental health conditions arising
16	out of, or complicated by, such Hurricane and its after-
17	math.
18	(b) Availability of Amounts.—Reimbursement
19	under this section shall be available for services furnished
20	during the 2-year period beginning on August 29, 2005.
21	(e) Nonduplication of Benefits.—
22	(1) In general.—Subject to paragraph (2),
23	reimbursement under this section shall not be avail-
24	able for treatment to the extent other reimburse-
25	ment is available for such treatment.

1 (2) COVERAGE OF STATE SHARE OF MEDICAID
2 AND SCHIP.—Reimbursement under this section
3 shall be available to States to cover the State share
4 of costs of treatment described in subsection (a) pro5 vided to beneficiaries under title XIX or XXI of the
6 Social Security Act who are victims of, or first re7 sponders to, Hurricane Katrina.
