## A BILL

To authorize the Secretary of Veterans Affairs to provide emergency assistance to homeless veterans and their families affected by Hurricane Katrina, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,

- 2 FORECLOSED HOMES FOR VETERANS AND
- 3 DISPLACED PERSONS.
- 4 (a) Use of Foreclosed Homes.—(1) In the case
- 5 of any residential property on which the Department of
- 6 Veterans Affairs has foreclosed or which the Secretary of
- 7 Veterans Affairs has acquired pursuant to section 3732
- 8 of title 38, United States Code, that the Secretary deter-
- 9 mines to be suitable, the Secretary shall make such prop-
- 10 erty available to an entity described in paragraph (2) or
- 11 to another entity designated by the Director of the Federal
- 12 Emergency Management Agency for use as a temporary
- 13 residence for Hurricane Katrina-affected individuals. The
- 14 period for which such a property may be made available
- 15 for use as a temporary residence under this section may
- 16 not exceed two years.
- 17 (2) An entity referred to in paragraph (1) is an entity
- 18 described in subparagraph (A) or (B) of section
- 19 2041(a)(1) of title 38, United States Code.
- 20 (3) An entity to which a residential property is made
- 21 available under paragraph (1) shall give priority in pro-
- 22 viding shelter to those Hurricane Katrina-affected individ-
- 23 uals who are veterans, surviving spouses of veterans, and
- 24 children of veterans (as those terms are defined in section
- 25 101 of title 38, United States Code), and their families.

- 2 Veterans Affairs shall consult with the Under Secretary
- 3 of Homeland Security for Emergency Preparedness and

- 5 (b) Reimbursement of Certain Expendi-
- 6 Tures.—Consistent with section 304 of the Robert T.
- 7 Stafford Disaster Relief and Emergency Assistance Act
- 8 (42 U.S.C. 5147), the Director of the Federal Emergency
- 9 Management Agency shall reimburse the Secretary of Vet-
- 10 erans Affairs for any expenditures of the Department of
- 11 Veterans Affairs relating to the repair, maintenance, or
- 12 management of properties owned by the Department of
- 13 Veterans Affairs to the extent that such repair, mainte-
- 14 nance, or management is for the purpose of making such
- 15 properties available as temporary residences for Hurricane
- 16 Katrina-affected individuals under the authority of section
- 17 3720 of title 38, United States Code.
- 18 (c) Hurricane Katrina-Affected Individual
- 19 Defined.—For purposes of this Act, the term "Hurri-
- 20 cane Katrina-affected individual" means an individual who
- 21 as of August 28, 2005, resided in, or was employed in,
- 22 a county adversely affected by Hurricane Katrina in the
- 23 State of Florida, Louisiana, Mississippi, or Alabama that
- 24 is designated for individual assistance or public assistance
- 25 by Federal Disaster Declaration notice 1602, 1603, 1604,

- 1 or 1605, respectively (as amended), issued by the Federal
- 2 Emergency Management Agency.
- 3 (d) Publication of Regulations.—The Secretary
- 4 is not required to publish in the Federal Register regula-
- 5 tions to carry out this section.
- 6 SEC. 2. EMERGENCY GRANTS TO ORGANIZATIONS FOR
- 7 PROVISION OF SHELTER TO HOMELESS VET-
- 8 ERANS AND THEIR FAMILIES.
- 9 (a) AUTHORITY.—The Secretary of Veterans Affairs
- 10 is authorized to make emergency grants to entities de-
- 11 scribed in section 1(a)(2) for the purpose of providing
- 12 housing assistance to homeless veterans (as defined in sec-
- 13 tion 2002 of title 38, United States Code) who are Hurri-
- 14 cane Katrina-affected individuals and their families for a
- 15 period not to exceed two years.
- 16 (b) Eligibility.—To be eligible to receive an emer-
- 17 gency grant under this subsection, such an entity shall
- 18 have the capacity (as determined by the Secretary) to ef-
- 19 fectively administer such a grant.
- 20 (c) Provision of Notice.—The Secretary shall pro-
- 21 vide notice of the availability of emergency grants on the
- 22 Internet website of the Department of Veterans Affair and
- 23 use such other means of notice as the Secretary may de-
- 24 termine are appropriate.

- 1 (d) Report.—Not later than 30 days after the date
- 2 of the enactment of this Act, the Secretary shall submit
- 3 to the Committee on Veterans' Affairs of the House of
- 4 Representatives and the Committee on Veterans' Affairs
- 5 of the Senate a report specifying the number of grants
- 6 awarded under this section and the identity of each grant
- 7 recipient.
- 8 (e) Publication of Regulations.—The Secretary
- 9 is not required to publish in the Federal Register regula-

- 11 (f) TERMINATION OF AUTHORITY.—The authority of
- 12 the Secretary to make grants under this section shall ter-
- 13 minate on September 30, 2007.

- 17 (a) Authority for Use of Underutilized De-
- 18 PARTMENT OF VETERANS AFFAIRS PROPERTY AS TEM-
- 19 PORARY VETERAN HOUSING.—Subchapter I of chapter 81
- 20 of title 38, United States Code, is amended by adding at
- 21 the end the following new section:
- 22 "§ 8119. Underutilized property: housing for veterans
- 23 during emergency
- 24 "(a) AUTHORITY.—Notwithstanding any other provi-
- 25 sion of this title or of any other law, during or following

- 1 a period of emergency or disaster declared by the Presi-
- 2 dent pursuant to the Robert T. Stafford Disaster Relief
- 3 and Emergency Assistance Act (42 U.S.C. 5121 et seq.),
- 4 the Secretary may use underutilized Department property
- 5 that is habitable or that can be rendered habitable with
- 6 limited resources, as determined by the Secretary, to
- 7 house, for a period not to exceed 180 days, veterans and
- 8 their dependents who are displaced as a result of such
- 9 emergency or disaster.
- 10 "(b) Underutilized Department Property.—
- 11 For purposes of this section, the term 'underutilized De-
- 12 partment property' means an asset of the Department
- 13 that is so identified by the Capital Asset Realignment for
- 14 Enhanced Services or otherwise identified by the Sec-
- 15 retary.".
- 16 (b) CLERICAL AMENDMENT.—The table of sections
- 17 at the beginning of chapter 81 of title 38, United States
- 18 Code, is amended by inserting after the item relating to
- 19 section 8118 the following new item:
  - "8119. Underutilized property: housing for veterans during emergency.".
- 20 SEC. 4. EMERGENCY GRANTS FOR REPLACEMENT OR RE-
- 21 PAIR OF HOMELESS VETERAN FACILITIES.
- 22 (a) Emergency Grant Authority.—Subchapter II
- 23 of chapter 20 of title 38, United States Code, is amended
- 24 by adding at the end the following new section:

## 1 "§ 2014. Emergency grants for repair or replacement

- 2 of homeless veteran facilities
- 3 "(a) AUTHORITY.—The Secretary may make emer-
- 4 gency grants to eligible entities providing care for home-
- 5 less veterans for the purpose of repairing or replacing fa-
- 6 cilities used for the provision of such care that are dam-
- 7 aged or destroyed by a disaster.
- 8 "(b) Eligible Entity.—In this section, the term
- 9 'eligible entity' has the meaning given that term in section
- 10 2011(d) of this title.
- 11 "(c) Establishment of Criteria and Require-
- 12 Ments.—The Secretary shall establish criteria and re-
- 13 quirements for grants under this section and shall publish
- 14 such criteria and requirements in the Federal Register.
- 15 "(d) DISASTER.—In this section, the term 'disaster'
- 16 means any hurricane, tornado, storm, flood, high water,
- 17 wind-driven water, tidal wave, tsunami, earthquake, vol-
- 18 canic eruption, landslide, mudslide, snowstorm, drought,
- 19 fire, explosion, or other catastrophe in any part of the
- 20 United States which causes, or which may cause, substan-
- 21 tial damage or injury to civilian property or persons.".
- 22 (b) Clerical Amendment.—The table of sections
- 23 at the beginning of chapter 20 of such title is amended
- 24 by inserting after the item relating to section 2013 the
- 25 following new item:

"2014. Emergency grants for repair or replacement of homeless veteran facilities.".
