1	SEC. 2. EMERGENCY ADJUSTMENT IN BASIC ALLOWANCE
2	FOR HOUSING IN RESPONSE TO INCREASED
3	ENERGY COSTS.
4	Section 403(b)(4) of title 37, United States Code, is
5	amended—
6	(1) by striking "An adjustment" and inserting
7	"(A) Except as provided in subparagraph (B), an
8	adjustment"; and
9	(2) by adding at the end the following new sub-
10	paragraph:
11	"(B) The Secretary may make an emergency adjust-
12	ment in the rates of the basic allowance for housing for
13	a particular military housing area in response to a sudden
14	increase in energy costs in the area as a result of higher
15	charges for utilities or other causes. An adjustment in the
16	rates of the basic allowance for housing under the author-
17	ity of this subparagraph may take effect in advance of the
18	effective date specified in subparagraph (A), and, notwith-
19	standing paragraph (6), shall remain in effect for a period
20	determined by the Secretary, but not to exceed six months.
21	The Secretary shall provide written notice to Congress of
22	any rate adjustment made under this subparagraph and
23	the reasons for the adjustment.".

1	SEC. 3. EMERGENCY ADJUSTMENT IN COST-OF-LIVING AL-
2	LOWANCE IN RESPONSE TO INCREASED GAS-
3	OLINE COSTS.
4	Section 403b(d) of title 37, United States Code, is
5	amended—
6	(1) by redesignating paragraphs (1) and (2)
7	and subparagraphs (A) and (B) of such paragraph
8	(2) as subparagraphs (A) and (B) and clauses (i)
9	and (ii), respectively;
10	(2) by inserting "(1)" before "The cost-of-liv-
11	ing"; and
12	(3) by adding at the end the following new
13	paragraph:
14	"(2) The Secretary may make an emergency adjust-
15	ment in the amount of the cost-of-living allowance other-
16	wise in effect under paragraph (1), and establish tem-
17	porary high cost areas for purposes of this section during
18	a fiscal year, in response to a sudden increase in gasoline
19	prices in an area. An adjustment in the amount of a cost-
20	of-living allowance or the establishment of a temporary
21	high cost area under the authority of this subparagraph
22	shall take effect on such date as determined by the Sec-
23	retary to be appropriate and shall remain in effect for a
24	period determined by the Secretary, but not to exceed six
25	months. The Secretary shall provide written notice to Con-
26	gress of any cost-of-living allowance adjustment made or
