A BILL

To amend title 18, United States Code, to provide criminal penalties for price gouging during times of disaster.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Prohibiting Reprehen-
- 5 sible Increases in Costs of Essentials (PRICE) Act of
- 6 2005".
- 7 SEC. 2. PRICE GOUGING.
- 8 (a) TITLE 18 AMENDMENT.—Chapter 89 of title 18,
- 9 United States Code, is amended by adding at the end the
- 10 following:

1 "§ 1822. Price gouging during times of disaster

- 2 "(a) Whoever engages in price gouging in a time and
- 3 place of disaster shall be fined as provided in subsection
- 4 (b) or imprisoned one year, or both.
- 5 "(b) The fine for an offense under this section shall
- 6 be computed as follows:
- 7 "(1) Except as provided in paragraph (2), mul-
- 8 tiply the amount of the profit made through the of-
- 9 fense by the number of days that the price gouging
- has occurred.
- "(2) If the gross disparity in prices is 50 per-
- cent or more, multiply by 2 the amount calculated
- in paragraph (1).
- 14 "(c) It is a defense to a prosecution for a violation
- 15 of this section that the increase in the amount charged
- 16 is attributable to additional costs incurred in connection
- 17 with the rental or sale of the commodity or rental or lease
- 18 of any dwelling unit or self-storage facility, or national or
- 19 international market trends
- 20 "(d) As used in this section:
- 21 "(1) The term 'price gouging' means charging
- a grossly disproportionate price;
- 23 "(2) The term 'time and place of disaster'
- 24 means a time during which and a place with respect
- 25 to which the chief executive of a State with respect
- to a State, or the President with respect to the

- United States, has declared a disaster to have taken
 place.
 - "(3) The term 'grossly disproportionate' with respect to a price, means there is a gross disparity between the price of the commodity or rental or lease of any dwelling unit or self-storage facility that is the subject of the offer or transaction and the average price at which that commodity or dwelling unit or self-storage facility was rented, leased, sold, or offered for rent or sale in the usual course of business during the 30 days immediately prior to the declaration of a state of emergency.
 - "(4) The term 'commodity' means any good, service, material, merchandise, supply, equipment, resource, or any article of commerce, and includes gasoline, food, water, ice chemicals, and lumber.
 - "(5) The term 'gross disparity' means a 25 percent increase.".
