A BILL

- 4 (a) Sale of National Forest Lands.—The Sec-
- 5 retary of Agriculture shall select 15 percent of the lands
- 6 included in the National Forest System (as defined in sec-
- 7 tion 11(a) of the Forest and Rangeland Renewable Re-
- 8 sources Planning Act of 1974 (16 U.S.C. 1609(a))) and
- 9 convey all right, title, and interest of the United States
- 10 in and to the selected lands by public sale.
- 11 (b) Sale of Department of the Interior
- 12 Lands.—The Secretary of the Interior shall identify 15
- 13 percent of the lands managed by agencies of the Depart-
- 14 ment of the Interior (excluding lands in units of the Na-
- 15 tional Park System established by Act of Congress and
- 16 lands held for the benefit of an Indian tribe) and convey
- 17 all right, title, and interest of the United States in and

- 19 (c) Priority Locations.—The Secretary of Agri-

- section (g), the Secretary of the Treasury shall man-
- age amounts in the special account to maximize the

- 19 (g) Use of Fund for Disaster Relief.—
- 20 Amounts in the special account shall be available only for

- 2 TION.—Until the Secretary of Agriculture and the Sec-
- 3 retary of the Interior comply with the duties imposed on
- 4 the Secretaries by this section, an interest in land may
- 5 not be acquired by the Forest Service or an agency of the
- 6 Department of the Interior unless the acquisition of that
- 7 land is specifically authorized by an Act of Congress en-
- 8 acted after the date of the enactment of this Act.
