## A BILL

To revise and extend the National Police Athletic League Youth Enrichment Act of 2000.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “National Police Ath-  
5 letic League (PAL) Youth Enrichment Reauthorization  
6 Act of 2005”.

1 **SEC. 2. PUBLIC LAW 106–367.**

2 Section 1 of Public Law 106–367 (42 U.S.C. 13751  
3 note) is amended by striking “2000” and inserting  
4 “2005”.

5 **SEC. 3. NAME OF LEAGUE.**

6 Public Law 106–367 (42 U.S.C. 13751 note) is  
7 amended by striking “Athletic” each place such term ap-  
8 pears and inserting “Athletic/Activities”.

9 **SEC. 4. FINDINGS.**

10 Section 2 of Public Law 106–367 (42 U.S.C. 13751  
11 note) is amended—

12 (1) in paragraph (1)—

13 (A) by redesignating subparagraphs (C)  
14 through (G) as subparagraphs (D) through  
15 (H), respectively; and

16 (B) by inserting after subparagraph (B)  
17 the following:

18 “(C) develop life enhancing character and  
19 leadership skills in young people;”;

20 (2) in paragraph (2) by striking “55” and in-  
21 serting “90”;

22 (3) in paragraph (3)—

23 (A) by striking “320” and inserting  
24 “350”; and

25 (B) by striking “1,500,000” and inserting  
26 “2,000,000”;

1           (4) in paragraph (4), by striking “82” and in-  
2       serting “85”;

3           (5) in paragraph (5), in the second sentence, by  
4       striking “receive no” and inserting “rarely receive”;

5           (6) in paragraph (6), by striking “17” and in-  
6       serting “18”; and

7           (7) in paragraph (7), by striking “1999” and  
8       inserting “2005”.

9   **SEC. 5. PURPOSE.**

10       Section 3 of Public Law 106–367 (42 U.S.C. 13751  
11   note) is amended—

12           (1) in paragraph (1), by striking “320” and in-  
13       serting “342”;

14           (2) in paragraph (2), by striking “2006” and  
15       inserting “2010”; and

16           (3) by adding at the end the following new  
17       paragraph:

18           “(3) support of an annual gathering of PAL  
19       chapters and designated youth leaders from such  
20       chapters to participate in a three-day conference  
21       that addresses national and local issues impacting  
22       the youth of America and includes educational ses-  
23       sions to advance character and leadership skills.”.

1 **SEC. 6. DEFINITIONS.**

2 Section 4(4) of Public Law 106–367 (42 U.S.C.  
3 13751 note) is amended in the heading for paragraph (4)  
4 by striking “ATHLETIC” and inserting “ATHLETIC/ACTIVI-  
5 TIES”.

6 **SEC. 7. GRANTS AUTHORIZED.**

7 Section 5 of Public Law 106–367 (42 U.S.C. 13751  
8 note) is amended—

9 (1) in subsection (a), by striking “2001 through  
10 2005” and inserting “2006 through 2010”; and

11 (2) in subsection (b)(1), in subparagraph (B),  
12 by striking “[not less than] 570 PAL chapters in  
13 operation before January 1, 2004” and inserting  
14 “[not fewer than] 500 PAL chapters in operation  
15 before January 1, 2010”.

16 **SEC. 8. USE OF FUNDS.**

17 Section 6(a)(2) of Public Law 106–367 (42 U.S.C.  
18 13751 note) is amended—

19 (1) in the matter preceding subparagraph (A),  
20 by striking “four” and inserting “two”; and

21 (2) in subparagraph (A)—

22 (A) in the matter preceding clause (i), by  
23 striking “two” and inserting “one”;

24 (B) in clause (iii), by striking “or”;

25 (C) in clause (iv), by striking “and” and  
26 inserting “or”; and

1 (D) by inserting after clause (iv) the fol-  
2 lowing:

3 “(v) character development and lead-  
4 ership training; and”.

5 **SEC. 9. AUTHORIZATION OF APPROPRIATIONS.**

6 Section 8(a) of Public Law 106–367 (42 U.S.C.  
7 13751 note) is amended by striking “2001 through 2005”  
8 and inserting “2006 through 2010”.

9 **SEC. 10. EFFECTIVE DATE.**

10 The amendments made by this Act take effect Octo-  
11 ber 1, 2005, or upon the date of the enactment of this  
12 Act, whichever occurs later.
