- To amend the Help America Vote Act of 2002 to require States to keep confidential the addresses of victims of domestic violence which are included in the State's computerized Statewide voter registration list, and for other purposes.
 - 1 Be it enacted by the Senate and House of Representa-
 - 2 tives of the United States of America in Congress assembled,
 - 3 SECTION 1. SHORT TITLE.
 - 4 This Act may be cited as the "Victims of Violence
 - 5 Confidentiality Act of 2005".

1	SEC. 2. CONFIDENTIALITY OF ADDRESSES OF VICTIMS OF
2	DOMESTIC VIOLENCE WITHIN COMPUTER-
3	IZED STATEWIDE VOTER REGISTRATION
4	LIST.
5	(a) Confidentiality of Addresses Required.—
6	Section 303(a) of the Help America Vote Act of 2002 (42
7	U.S.C. 15483(a)) is amended by adding at the end the
8	following new paragraph:
9	"(6) Confidentiality of addresses of vic-
10	TIMS OF DOMESTIC VIOLENCE.—
11	"(A) IN GENERAL.—In administering the
12	computerized Statewide voter registration list,
13	the State shall ensure that the address of any
14	individual who is registered to vote in the State
15	and who provides the appropriate election offi-
16	cial with the documentation described in sub-
17	paragraph (B), as well as the address of any
18	other individual who resides at that address,
19	does not appear within the database and is not
20	otherwise accessible to any person who is not an
21	election official.
22	"(B) Documentation.—The documenta-
23	tion described in this subparagraph is—
24	"(i) a copy of an order of protection
25	issued by a judicial authority to protect the

1	individual from domestic violence, sexual
2	abuse, or stalking; or
3	"(ii) an affidavit stating that the indi-
4	vidual is a victim of domestic violence, sex-
5	ual abuse, or stalking.
6	"(C) Information.—The State shall take
7	such steps as may be required to ensure that
8	individuals registered to vote in the State and
9	individuals applying to register to vote in the
10	State, as well as all election officials in the
11	State, are aware of the requirements of this
12	paragraph.".
13	(b) Effective Date.—Section 303(d)(1) of such
14	Act (42 U.S.C. 15483(d)(1)) is amended—
15	(1) in subparagraph (A), by striking "subpara-
16	graph (B)" and inserting "subparagraphs (B) and
17	(C)";
18	(2) by redesignating subparagraph (B) as sub-
19	paragraph (C); and
20	(3) by inserting after subparagraph (A) the fol-
21	lowing new subparagraph:
22	"(B) Special rule for confiden-
23	TIALITY REQUIREMENTS.—Each State and ju-
24	risdiction shall be required to comply with the

requirements of subsection (a)(6) on and after 1 2 January 1, 2006.". 3 SEC. 3. AUTHORIZATION OF APPROPRIATIONS. 4 Section 257(a) of the Help America Vote Act of 2002 (42 U.S.C. 15407(a)) is amended by adding at the end the following new paragraph: 6 "(4) For fiscal year 2006, such sums as may be 7 necessary for States to meet the requirements of sec-8 9 tion 303(a)(6), except that the amounts made available pursuant to the authorization under this para-10 11 graph may be used only to meet such require-12 ments.".
