 - 1 Be it enacted by the Senate and House of Representa-
 - 2 tives of the United States of America in Congress assembled,
 - 3 SECTION 1. SHORT TITLE.
 - 4 This Act may be cited as the "Modifications to the
 - 5 Pima County Wastewater Management Regional Treat-
 - 6 ment System for Improved Reclaimed Water Production
 - 7 Act".

SEC. 2. PROJECT AUTHORIZATION.

- 2 (a) IN GENERAL.—The Reclamation Wastewater and
- 3 Groundwater Study and Facilities Act (Public Law 102–
- 4 575, title XVI; 43 U.S.C. 390h et seq.) is amended by
- 5 adding after section 16____ the following:
- 6 "SEC. 16 . MODIFICATIONS TO THE PIMA COUNTY
- 7 WASTEWATER MANAGEMENT REGIONAL
- 8 TREATMENT SYSTEM FOR IMPROVED RE-
- 9 CLAIMED WATER PRODUCTION, PIMA COUN-
- 10 TY, ARIZONA.
- 11 "(a) AUTHORIZATION.—The Secretary, in coopera-
- 12 tion with Pima County, Arizona, may participate in the
- 13 planning, design, and construction of modifications to
- 14 water recycling facilities and to provide advanced treat-
- 15 ment for production of reclaimed water for use in environ-
- 16 mental restoration, recharge and reclaimed water projects
- 17 for the towns, cities, and unincorporated areas of Pima
- 18 County.
- 19 "(b) Cost Sharing.—The Federal share of the cost
- 20 of the project described in subsection (a) shall not exceed
- 21 25 percent of the cost of the project.
- 22 "(c) Limitation.—Federal funds provided under
- 23 this section shall not be used for operation or maintenance
- 24 of the project described in subsection (a).

"(d) AUTHORIZATION OF APPROPRIATIONS.—There
is authorized to be appropriated to carry out this section
\$20,000,000.".
(b) CLERICAL AMENDMENT.—The table of sections
for Public Law 102–575 is amended by inserting after the
item relating to section 16_____ the following:
