## A BILL

To provide veterans benefits to certain individuals who serve in the United States merchant marine during a period of war.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Combat Merchant
- 5 Mariners Veterans Benefits Act of 2005".
- 6 SEC. 2. ELIGIBILITY FOR VETERANS BENEFITS.
- 7 (a) In General.—Subject to subsection (b), the
- 8 qualifying service of an individual in the United States
- 9 merchant marine during a period of war for a total period
- 10 equal to at least 12 months shall be considered to be active

- 1 duty in determining the individual's eligibility for veterans
- 2 benefits under all laws administered by the Secretary of
- 3 Veterans Affairs.
- 4 (b) Qualifying Service.—For purposes of this sec-
- 5 tion, qualifying service is any of the following:
- 6 (1) Ocean, coastal, or intercoastal voy-
- 7 AGES.—Service on a vessel of the United States on
- 8 ocean, coastwise, or intercoastal voyages during a
- 9 period of war in a combat zone of such war if such
- service is rendered to the Armed Forces in a capac-
- ity considered civilian employment or contractual
- service at the time the service is performed.
- 13 (2) Forcible Detention or Internment.—
- Any period of forcible detention or internment by an
- enemy government or hostile force as a result of hos-
- tile action against a vessel of the United States
- while the individual was performing service referred
- to in paragraph (1) on that vessel.
- 19 (3) OTHER SERVICE.—Any period of service in
- the War Shipping Administration, the United States
- 21 Maritime Service, or a maritime training program
- conducted or recognized by the Armed Forces, ex-
- cept that not more than six months of such service
- 24 may be included in calculating the period of service
- referred to in subsection (a).

- 3 (1) The term "individual in the United States 4 merchant marine" means any citizen or resident 5 alien of the United States serving as a civilian or 6 civil service member of the United States merchant 7 marine.
- 8 (2) The terms "period of war" and "Armed 9 Forces" have the meanings given those terms in sec-10 tion 101 of title 38, United States Code.
- 11 (3) The term "combat zone" means an area in 12 which the Armed Forces are engaged in combat, as 13 determined by the Secretary of Defense.
- 14 (4) The term "vessel of the United States" has 15 the meaning given that term in section 2101(46) of 16 title 46, United States Code.

### 17 SEC. 6. APPLICABILITY AND PROHIBITION OF RETRO-

### 18 ACTIVE BENEFITS.

- 19 Service referred to in section 2(a) that was performed
- 20 before the date of the enactment of this Act shall be count-
- 21 ed for purposes of this Act. An individual who performs
- 22 such service before the date of the enactment of this Act
- 23 may not be provided veterans benefits that accrue as a
- 24 result of the enactment of this Act for any period before
- 25 the date of the enactment of this Act.
