1	SECTION 1. ESTABLISHMENT AND CONSULTATION OF
2	SMALL BUSINESS DATABASE BY SECRETARY
3	OF HOMELAND SECURITY.
4	(a) Establishment and Consultation.—Title V
5	of the Homeland Security Act of 2002 (6 U.S.C. 311 et
6	seq.) is amended—
7	(1) by redesignating the second section 510 as
8	section 511; and
9	(2) by adding at the end the following new sec-
10	tion:
11	"SEC. 512. SMALL BUSINESS DATABASE FOR FEDERAL CON-
12	TRACTING RELATED TO MAJOR DISASTERS
13	AND EMERGENCY ASSISTANCE ACTIVITIES:
14	ESTABLISHMENT AND CONSULTATION.
15	"(a) Establishment of Database.—The Sec-
16	retary, acting through the Director of the Federal Emer-
17	gency Management Agency, shall establish and maintain
18	a database of small business concerns.
19	"(b) Included Information.—The database under
20	subsection (a) shall include the following information
21	about each small business concern:
22	"(1) The name of the small business concern.
23	"(2) The location of the small business concern.
24	"(3) The area served by the small business con-

11	"(c) Source of Information.—
12	"(1) Submission.—Information maintained in
13	the database shall be submitted on a voluntary basis

13	"(d) AVAILABILITY OF DATABASE.—The database
14	shall be made generally available on the Internet website
15	of the Department.
16	"(e) Consultation of Database.—
17	"(1) Consultation required.—Before
18	awarding a Federal contract for a disaster-related
19	activity a Federal agency shall consult the database
20	established under this section.
21	"(2) DISASTER-RELATED ACTIVITY DEFINED.—
22	For purposes of this subsection, a disaster-related
23	activity is an activity undertaken by reason of an
24	event that is declared an emergency or a disaster by
25	the President pursuant to the Robert T. Stafford

- 2 U.S.C. 5121 et seq.).
- 3 "(f) Definitions.—For purposes of this section, the
- 4 terms 'small business concern', 'small business concern
- 5 owned and controlled by socially and economically dis-
- 6 advantaged individuals', 'small business concern owned
- 7 and controlled by women', and 'small business concern
- 8 owned and controlled by service-disabled veterans' shall
- 9 have the meanings given those terms under the Small
- 10 Business Act (15 U.S.C. 631 et seq.).".
- 11 (b) CLERICAL AMENDMENT.—The table of contents
- 12 in section 1(b) of the Homeland Security Act of 2002 is
- 13 amended by adding after the items relating to section 509
- 14 the following:
 - "Sec. 510. Procurement of security countermeasures for strategic national stockpile.
 - "Sec. 511. Urban and other high risk area communications capabilities.
 - "Sec. 512. Small business database for Federal contracting related to declared emergencies: establishment and consultation.".
- 15 (c) Effective Date.—The Secretary shall establish
- 16 the database required under section 512 of the Homeland
- 17 Security Act of 2002 (as added by subsection (a)) not later
- 18 than the date that is 60 days after the date of the enact-
- 19 ment of this Act.
