To amend title 38, United States Code, to provide housing loan benefits for the purchase of residential cooperative apartment units.

- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Veterans Housing
- 5 Fairness Act of 2005".
- 6 SEC. 2. RESIDENTIAL COOPERATIVE HOUSING UNITS.
- 7 (a) Housing Benefits for Cooperative Apart-
- 8 MENT UNITS.—Section 3710(a) of title 38, United States

- 1 Code, is amended by inserting after paragraph (11) the
- 2 following new paragraph:
- 3 "(12) To purchase stock or membership in a
- 4 development, project or structure of a cooperative
- 5 housing corporation in accordance with subsection
- 6 (h).".
- 7 (b) Conditions of Housing Benefits for Coop-
- 8 ERATIVE APARTMENT UNITS.—Section 3710 of such title
- 9 is amended by adding at the end the following new sub-
- 10 section:
- 11 "(h)(1) A loan may not be guaranteed under sub-
- 12 section (a)(12) unless the following conditions are met:
- "(A) The development, project or structure of
- the cooperative housing corporation complies with
- such criteria as the Secretary prescribes in regula-
- tions.
- 17 "(B) The dwelling unit, that the purchase of
- stock or membership in the development, project or
- structure of the cooperative housing corporation en-
- 20 titles the purchaser to occupy, is a one-family resi-
- 21 dential unit.
- "(2) For the purposes of this subsection, the term
- 23 'cooperative housing corporation' has the same meaning
- 24 given such term by section 216(b)(1) of the Internal Rev-
- 25 enue Code of 1986.

- 1 "(3) For the purposes of applying the term 'value of
- 2 the property' to a loan guaranteed under subsection
- 3 (a)(12), such term means the appraised value of the stock
- 4 or membership entitling the purchaser to the permanent
- 5 occupancy of the dwelling unit in the development, project
- 6 or structure of the cooperative housing corporation.".
