# A BILL

To prohibit the manufacture, processing, possession, or distribution in commerce of the poison sodium fluoroacetate (known as "Compound 1080"), to provide for the collection and destruction of remaining stocks of sodium fluoroacetate, to compensate persons who turn in sodium fluoroacetate to the Secretary of Agriculture for destruction, and for other purposes."

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,

#### 1 SECTION 1. SHORT TITLE.

- 2 This Act may be cited as the "Sodium Fluoroacetate
- 3 Elimination Act".
- 4 SEC. 2. IMMEDIATE PROHIBITION ON MANUFACTURE,
- 5 PROCESSING, OR DISTRIBUTION IN COM-
- 6 MERCE OF SODIUM FLUOROACETATE (COM-
- 7 **POUND 1080).**
- 8 (a) Amendment of Toxic Substances Control
- 9 Act.—Section 6 of the Toxic Substances Control Act (15
- 10 U.S.C. 2605) is amended by adding at the end the fol-
- 11 lowing new subsection:
- 12 "(f) Compound 1080.—No person may manufac-
- 13 ture, process, or distribute in commerce sodium
- 14 fluoroacetate (known as 'Compound 1080'). ".
- 15 (b) Effective Date.—The amendment made by
- 16 subsection (a) shall take effect on the date of the enact-
- 17 ment of this Act.
- 18 SEC. 3. COLLECTION AND DESTRUCTION OF STOCKS OF SO-
- 19 **DIUM FLUOROACETATE.**
- 20 (a) Collection.—During the 18-month period be-
- 21 ginning on the first day of the first month beginning on
- 22 or after the date of the enactment of this Act, the Sec-
- 23 retary of Agriculture shall solicit and accept the transfer
- 24 of stocks of the poison sodium fluoroacetate (known as
- 25 "Compound 1080") held in public or private ownership
- 26 in the United States.

- 1 (b) Compensation.—The Secretary of Agriculture
- 2 shall compensate persons (other than a Federal agency)
- 3 that transfer sodium fluoroacetate to the Secretary during
- 4 the period specified in subsection (a) for the reasonable
- 5 value of the sodium fluoroacetate acquired by the Sec-
- 6 retary.
- 7 (c) Destruction.—The Secretary of Agriculture
- 8 shall destroy all sodium fluoroacetate acquired under this
- 9 section and all stocks of sodium fluoroacetate held by the
- 10 Department of Agriculture as of the date of the enactment
- 11 of this Act. The Secretary may not use sodium
- 12 fluoroacetate in the Wildlife Services Program of the De-
- 13 partment.
- 14 (d) INVENTORY.—During the period specified in sub-
- 15 section (a), the Secretary of Agriculture shall conduct an
- 16 inventory in an attempt to identify those persons who hold
- 17 stocks of sodium fluoroacetate so that such persons are
- 18 given the opportunity to transfer the sodium fluoroacetate
- 19 to the Secretary under this section and to receive com-
- 20 pensation for the sodium fluoroacetate. The Secretary of
- 21 Agriculture shall conduct the inventory in cooperation
- 22 with the Administrator of the Environmental Protection
- 23 Agency and the Secretary of Homeland Security.
- 24 (e) Funding Source.—Amounts appropriated to
- 25 the Department of Agriculture for the Wildlife Services

- 1 Program shall be available to provide the compensation
- 2 required by subsection (b). If such amounts are insuffi-
- 3 cient to provide compensation to all persons entitled to
- 4 compensation under such subsection, the Secretary of Ag-
- 5 riculture shall use other funds appropriated or otherwise
- 6 made available to the Department.

### 7 SEC. 4. PROHIBITION ON POSSESSION OF SODIUM

- 8 FLUOROACETATE.
- 9 (a) Prohibition.—Whoever (other than a person
- 10 acting under the authority of section 3(c)) possesses so-
- 11 dium fluoroacetate shall be fined under title 18, United
- 12 States Code, or imprisoned not more than two years, or
- 13 both.
- 14 (b) Effective Date.—This section shall take effect
- 15 at the end of the 18-month period beginning on the first
- 16 day of the first month beginning on or after the date of
- 17 the enactment of this Act.
