A BILL

To amend the David L. Boren National Security Education Act of 1991 to create a critical foreign language program.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "K–16 Critical Foreign
- 5 Language Pipeline Act".

1	SEC. 2. CRITICAL FOREIGN LANGUAGE EDUCATION PRO-
2	GRAM UNDER THE NATIONAL SECURITY EDU-
3	CATION PROGRAM.
4	(a) Program.—Section 802 of the David L. Boren
5	National Security Education Act of 1991 (50 U.S.C.
6	1902) is amended—
7	(1) in subsection $(a)(1)$ —
8	(A) in subparagraph (D), by striking
9	"and" at the end;
10	(B) in subparagraph (E), by striking the
11	final period and inserting "; and; and
12	(C) by adding at the end the following new
13	subparagraph:
14	"(F) awarding grants to institutions of
15	higher education to carry out activities under
16	the Critical Foreign Language Program de-
17	scribed in subsection (j)."; and
18	(2) by adding at the end the following new sub-
19	section:
20	"(j) Critical Foreign Language Program.—
21	"(1) Grants.—The Secretary of Defense shall
22	provide grants to five institutions of higher edu-
23	cation to establish a program to collaborate with ele-
24	mentary schools and secondary schools for language
25	learning pipelines to train students from kinder-
26	garten through college to be proficient in those for-

1	eign languages that the Secretary identifies as being
2	the most critical in the interests of the national se-
3	curity of the United States.
4	"(2) Program.—A program established pursu-
5	ant to a grant awarded under paragraph (1) may in-
6	clude—
7	"(A) study or work abroad;
8	"(B) experiential and community learning;
9	"(C) distance learning;
10	"(D) language learning for professional,
11	business, and other disciplines; and
12	"(E) innovative opportunities for language
13	learning through immersion, internships, and
14	community service.
15	"(3) Application requirements.—An appli-
16	cant for a grant under paragraph (1) shall—
17	"(A) demonstrate the ability to collaborate
18	effectively with elementary schools and sec-
19	ondary schools to ensure that students who suc-
20	cessfully achieve an advanced proficiency level
21	at such schools will continue studying a foreign
22	language at an institution for higher education
23	and achieve a superior proficiency level while
24	enrolled in an academic degree program;

1	"(B) demonstrate that the program de-
2	signed by the applicant for such a grant is able
3	to be replicated for use by other institutions of
4	higher education and elementary schools and
5	secondary schools in the United States; and
6	"(C) agree to provide funds for at least 10
7	percent of the cost of such program.
8	"(4) DISTRIBUTION OF FUNDS.—The Secretary
9	of Defense shall award an equal amount of the
10	funds appropriated pursuant to section 811(c) for a
11	fiscal year to each of the institutions of higher edu-
12	cation that are awarded grants pursuant to para-
13	graph (1) for such fiscal year.".
14	(b) Authorization of Appropriations.—Section
15	811 of the David L. Boren National Security Education
16	Act of 1991 (50 U.S.C. 1911) is amended—
17	(1) by redesignating subsection (c) as sub-
18	section (d); and
19	(2) by inserting after subsection (b) the fol-
20	lowing new subsection:
21	"(c) Funding for Critical Foreign Language
22	Program.—In addition to amounts that may be made
23	available to the Secretary under the Fund for a fiscal year,
24	there is authorized to be appropriated to the Secretary for
25	each fiscal year, beginning with fiscal year 2006,

- 1 \$5,000,000, to carry out the grant program for the Crit-
- 2 ical Foreign Language Program under section 802(j).".
