# A BILL

To establish within the Department of Health and Human Services the position of HIV/AIDS Emergency Response Coordinator in order to coordinate the provision of certain services to individuals with HIV disease who have been displaced as a result of Hurricane Katrina or Rita, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "HIV/AIDS Emergency
- 5 Hurricane Relief Act".

| 3  | (a) In General.—Not later than 30 days after the           |

| 8  | SEC. 3. AWARDS FOR SERVICES FOR ELIGIBLE INDIVID-         |
| 9  | UALS.   |
| 10 | (a) In General.—The Secretary, acting through the         |
| 11 | Coordinator and in consultation with the Administrator of |
| 12 | the Health Resources and Services Administration and the  |
| 13 | Secretary of Housing and Urban Development, shall make    |
| 14 | awards of grants or cooperative agreements to public and  |
| 15 | nonprofit private entities that—                          |
| 16 | (1) have experience in providing covered serv-            |
| 17 | ices to eligible individuals; or                          |
| 18 | (2) have received or are eligible to receive, di-         |
| 19 | rectly or indirectly, funding from the Federal gov-       |

| 23 | (b) General Provisions.—With respect to awards            |
| 24 | under subsection (a).                                     |

- 1 (1) Such an award may be made only if the applicant involved agrees that the award will not be expended for any purpose other than providing covered services.
  - (2) The Secretary shall publicize the availability of the awards and ensure that applications for such awards are processed not later than 45 days after the applications for the awards are submitted to the Secretary.
  - (3) In the case of an approved application, the Secretary shall ensure that funds under the award become available (subject to appropriations Acts) not later than 90 days after the date on which the application is submitted to the Secretary.
- 15 AVAILABILITY OFCERTAIN Unobligated Funds.—With respect to amounts appropriated for car-16 17 rying out part A or B of title XXVI of the Public Health 18 Service Act, such amounts that are unobligated at the end 19 of a fiscal year are available to the Secretary, acting 20 through the Administrator of the Health Resources and 21 Services Administration and in consultation with the Coor-22 dinator, for the purpose of making awards under sub-23 section (a).

| 7  | (a) IN GENERAL.—The Secretary, acting through the           |
| 8  | Administrator of the Health Resources and Services Ad-      |
| 9  | ministration and in consultation with the Coordinator, the  |
| 10 | head of the Federal Emergency Management Agency, and        |
| 11 | State and local governments, shall conduct a public aware-  |
| 12 | ness campaign directed toward eligible individuals who      |
| 13 | were receiving services under title XXVI of the Public      |

| 5  | In making awards of grants or cooperative agree-           |

| 8  | tributions as a condition of receiving the awards;         |
| 9  | (2) construe this Act as affecting the eligibility         |

| 19 | Not later than 180 days after the date of the enact-       |

| 22 | SEC. 9. DEFINITIONS.                                       |
| 23 | For purposes of this Act:                                  |
| 24 | (1) The term "covered services" means services             |
| 25 | described in section $2(b)(2)$ .                           |

- 1 (2) The term "eligible individuals" means indi-2 viduals described in section 2(b)(1).
- 3 (3) The term "HIV disease" has the meaning 4 given such term in section 2676 of the Public 5 Health Service Act.
- 6 (4) The term "Housing Opportunities for Per-7 sons With AIDS program" means the program 8 under subtitle D of title VIII of the Cranston-Gon-9 zalez National Affordable Housing Act.

#### 10 SEC. 10. AUTHORIZATION OF APPROPRIATIONS.

- 11 (a) In General .—For the purpose of carrying out 12 this Act, there is authorized to be appropriated 13 \$500,000,000 for fiscal year 2006. Amounts appropriated 14 under the preceding sentence shall remain available until
- 15 expended.
  16 (b) RULES OF CONSTRUCTION.—The authorization
  17 of appropriations established in subsection (a) is in addi18 tion to other authorizations of appropriations that are
  19 available for Federal programs that provide covered serv20 ices. Subsection (a) shall not be construed as reducing the
  21 authorizations of appropriations for title XXVI of the
  22 Public Health Service Act, the Housing Opportunities for
  23 Persons With AIDS program, or any other Federal pro-
