A BILL

- To limit assistance to the Palestinian Authority unless the President certifies to Congress that the Palestinian Authority is not controlled by a foreign terrorist organization, and for other purposes.
 - 1 Be it enacted by the Senate and House of Representa-
 - 2 tives of the United States of America in Congress assembled,
 - 3 SECTION 1. SHORT TITLE.
 - 4 This Act may be cited as the "Limitation on Assist-
 - 5 ance to the Palestinian Authority Act of 2006".

1 SEC. 2. FINDINGS.

- (1) In fiscal year 2005, the United States provided \$275 million to the West Bank and Gaza, of which \$50 million was provided directly to the Palestinian Authority.
 - (2) On January 25, 2006, the militant group Hamas, an organization designated by the Department of State as a foreign terrorist organization, won parliamentary elections and control of the Palestinian government.
 - (3) The inclusion of Hamas or any other foreign terrorist organization in a Palestinian government is an implicit endorsement of anti-American and anti-Israeli terrorist ideology.
 - (4) On December 16, 2005, the House of Representatives overwhelmingly passed House Resolution 575, which asserts that "terrorist organizations, such as Hamas, should not be permitted to participate in Palestinian elections until such organizations recognize Israel's right to exist as a Jewish state, cease incitement, condemn terrorism, and permanently disarm and dismantle their terrorist infrastructure".
 - (5) House Resolution 575 further asserts that "the inclusion of Hamas, or any other terrorist

- 1 group on the Department of State's list of foreign 2 the terrorist organizations, in Palestinian 3 Authority's government will inevitably raise serious questions for the United States about the commit-5 ment of the Palestinian Authority and its leadership 6 to making peace with Israel and will potentially un-7 dermine the ability of the United States to have a 8 constructive relationship with, or provide further as-9 sistance to, the Palestinian Authority".
- 10 (6) Hamas is a terrorist organization that has 11 killed more than 500 people since 1989, including 12 more than two dozen United States citizens.
- 13 (7) The United States has clearly stated that 14 armed militias attached to political parties are in-15 compatible with democratic societies.

16 SEC. 3. DECLARATION OF POLICY.

- 17 It shall be the policy of the United States to promote 18 the emergence of a democratic Palestinian government
- 19 that—
- 20 (1) denounces and combats terrorism;
- 21 (2) is actively working to disarm and dis-22 mantle terrorist agencies, networks, and facilities;
- 23 (3) is actively working to eliminate terrorist in-24 citement and the commemoration of terrorists in 25 Palestinian society;

1	(4) respects the boundaries and sovereignty of
2	its neighbors;
3	(5) recognizes the existence of Israel and its
4	right to secure borders; and
5	(6) acknowledges, respects, and upholds the
6	human rights of all people.
7	SEC. 4. LIMITATION ON ASSISTANCE TO THE PALESTINIAN
8	AUTHORITY.
9	Chapter 1 of part III of the Foreign Assistance Act
10	of 1961 (22 U.S.C. 2351 et seq.) is amended—
11	(1) by redesignating the second section 620G
12	(as added by section 149 of Public Law 104–164
13	(110 Stat. 1436)) as section 620J; and
14	(2) by adding at the end the following new sec-
15	tion:
16	"SEC. 620K. LIMITATION ON ASSISTANCE TO THE PALES-
17	TINIAN AUTHORITY.
18	"(a) Limitation.—Assistance may be provided
19	under this Act or any other provision of law to the Pales-
20	tinian Authority only during a period for which a certifi-
21	cation described in subsection (b) is in effect.
22	"(b) Certification.—A certification described in
23	this subsection is a certification transmitted by the Presi-
24	dent to Congress that contains a determination of the
25	President that—

1	"(1) the Palestinian Authority is not controlled
2	by a foreign terrorist organization; and
3	"(2) the Palestinian Authority—
4	"(A) recognizes the right of Israel to exist;
5	"(B) disarms all militias;
6	"(C) renounces violence and acts of ter-
7	rorism against Israel; and
8	"(D) takes definitive steps to be an active
9	and willing participant in peace negotiations
10	and removes people with ties to terrorist organi-
11	zations from its security services.
12	"(c) Recertifications.—Not later than 90 days
13	after the date on which the President transmits to Con-
14	gress an initial certification under subsection (b), and
15	every 6 months thereafter—
16	"(1) the President shall transmit to Congress a
17	recertification that the requirements contained in
18	subsection (b) are continuing to be met; or
19	"(2) if the President is unable to make such a
20	recertification, the President shall transmit to Con-
21	gress a report that contains the reasons therefor.
22	"(d) Congressional Notification.—Assistance
23	made available under this Act or any other provision of
24	law to the Palestinian Authority may not be provided until
25	15 days after the date on which the President has pro-

- 1 vided notice thereof to the Committee on International Re-
- 2 lations and the Committee on Appropriations of the House
- 3 of Representatives and to the Committee on Foreign Rela-
- 4 tions and the Committee on Appropriations of the Senate
- 5 in accordance with the procedures applicable to re-
- 6 programming notifications under section 634A(a) of this
- 7 Act.
- 8 "(e) Definitions.—In this section:
- 9 "(1) Foreign terrorist organization.—
- 10 The term 'foreign terrorist organization' means an
- organization designated as a foreign terrorist organi-
- zation by the Secretary of State in accordance with
- section 219(a) of the Immigration and Nationality
- 14 Act (8 U.S.C. 1189(a)).
- 15 "(2) Palestinian authority.—The term
- 16 'Palestinian Authority' includes any agency or in-
- strumentality of the Palestinian Authority.".
