A BILL

To establish a United States-Poland parliamentary youth exchange program, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "United States-Poland
- 5 Parliamentary Youth Exchange Program Act of 2006".
- 6 SEC. 2. FINDINGS.
- 7 Congress makes the following findings:
- 8 (1) The United States established diplomatic
- 9 relations with the newly-formed Polish Republic in
- 10 April 1919.

1 (2) The United States and Poland have enjoyed 2 close bilateral relations since 1989. 3 (3) Poland became a member of the North At-4 lantic Treaty Organization (NATO) in March 1999. (4) Poland became a member of the European 6 Union (EU) in May 2004. 7 (5) Poland has been a strong supporter, both 8 diplomatically and militarily, of efforts led by the 9 United States to combat global terrorism and has 10 contributed troops to the United States-led coalitions 11 in both Afghanistan and Iraq. 12 (6) Poland cooperates closely with the United 13 States on such issues as democratization, nuclear 14 proliferation, human rights, regional cooperation in 15 Eastern Europe, and reform of the United Nations. 16 (7) The United States and Poland seek to en-17 sure enduring ties between both governments and 18 societies. 19 (8) It is important to invest in the youth of the 20 United States and Poland in order to help ensure 21 long-lasting ties between both societies. 22 (9) It is in the interest of the United States to 23 preserve a United States presence in Europe and to 24 continue to contribute to the development of trans-

atlantic relationships.

- 1 (10) Poland for many years received inter-
- 2 national and United States financial assistance and
- 3 is now determined to invest its own resources toward
- 4 attaining its shared desire with the United States to
- 5 develop international cooperation.

6 SEC. 3. UNITED STATES-POLAND PARLIAMENTARY YOUTH

7 EXCHANGE PROGRAM.

- 8 (a) AUTHORITY.—The President, acting through the
- 9 Secretary of State and in cooperation with the Govern-
- 10 ment of Poland, may establish and carry out a parliamen-
- 11 tary exchange program for youth of the United States and
- 12 Poland.
- 13 (b) Designation.—The youth exchange program
- 14 carried out under this subsection shall be known as the
- 15 "United States-Poland Parliamentary Youth Exchange
- 16 Program".
- 17 (c) Purpose.—The purpose of the youth exchange
- 18 program is to demonstrate to the youth of the United
- 19 States and Poland the benefits of friendly cooperation be-
- 20 tween the United States and Poland based on common po-
- 21 litical and cultural values.
- 22 (d) Eligible Participants.—An individual is eligi-
- 23 ble for participation in the youth exchange program if the
- 24 individual—

1	(1) is a citizen or national of the United States
2	or of Poland;
3	(2) is under the age of 19 years;
4	(3) is a student who is enrolled and in good
5	standing at a secondary school in the United States
6	or Poland;
7	(4) has been accepted for up to one academic
8	year of study in a program of study abroad approved
9	for credit at such school; and
10	(5) meets any other qualifications that the
11	President may establish for purposes of the pro-
12	gram.
13	(e) Program Elements.—Under the youth ex-
14	change program, eligible participants selected for partici-
15	pation in the program shall—
16	(1) live in and attend a public secondary school
17	in the host country for a period of one academic
18	year;
19	(2) while attending public school in the host
20	country, undertake academic studies in the host
21	country, with particular emphasis on the history,
22	constitution, and political development of the host
23	country;

1	(3) be eligible, either during or after the com-
2	pletion of such academic studies, for an internship
3	in an appropriate position in the host country; and
4	(4) engage in such other activities as the Presi-
5	dent considers appropriate to achieve the purpose of
6	the program.
7	(f) RELATIONSHIP TO OTHER AUTHORITIES.—The
8	President may utilize the authorities and procedures set
9	out in title VIII of the United States Information and
10	Educational Exchange Act of 1948 (22 U.S.C. 1471 et
11	seq.) to establish and carry out the youth exchange pro-
12	gram.

10 SEC. 5. AUTHORIZATION OF APPROPRIATIONS.

- 11 (a) IN GENERAL.—There is authorized to be appro-12 priated for the Department of State for fiscal year 2007 13 such sums as may be necessary to carry out the youth 14 exchange program authorized by this Act.
- 15 (b) AVAILABILITY.—Amounts authorized to be appro-16 priated by subsection (a) shall remain available until ex-17 pended.
