Ms. Velázquez (for herself, Mr. Owens, Mr. Moran of Virginia, Mr. Hinojosa, Mr. Price of North Carolina, Mr. Serrano, Ms. Delauro, Mr. Farr, and Mr. Osborne) introduced the following bill; which was referred to the Committee on Education and the Workforce

A BILL

To establish the Silver Scholarship program to provide transferable educational awards to older individuals who have performed certain volunteer services.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SILVER SCHOLARSHIP PROGRAM.
- 4 Part A of title IV of the Older Americans Act of 1965
- 5 (42 U.S.C. 3001 et seq.) is amended by adding at the end
- 6 the following:

1 "SEC. 422. SILVER SCHOLARSHIP PROGRAM.

- 2 "(a) Establishment of Program.—The Assistant
- 3 Secretary may make grants to public agencies and non-
- 4 profit private organizations with experience in admin-
- 5 istering volunteer programs (including the programs car-
- 6 ried out under title II of the Domestic Volunteer Service
- 7 Act of 1973), to provide scholarships of not more than
- 8 \$1,000 per older individual in accordance with this sec-
- 9 tion.
- 10 "(b) Applications for Grants.—To request a
- 11 grant under this section, an agency or organization de-
- 12 scribed in subsection (a) shall submit to the Assistant Sec-
- 13 retary an application in such form and accompanied by
- 14 such information as the Assistant Secretary may reason-
- 15 ably require by rule. Such application shall include the
- 16 plan of the applicant to recruit, to retain, to manage, and
- 17 to train older individuals to serve as volunteers, including
- 18 older individuals with greatest economic need and older
- 19 individuals with limited English-speaking ability.
- 20 "(c) Scholarship Eligibility and Dollar
- 21 Amounts.—Subject to subsections (d) and (e), an agency
- 22 or organization that receives a grant under subsection (a)
- 23 shall award scholarships of \$1,000 per individual to eligi-
- 24 ble older individuals each of whom performed, during a
- 25 12-month period beginning after the effective date of this
- 26 section, not less than 600 hours of volunteer services of

- 1 the type determined to be appropriate by the Assistant
- 2 Secretary under subsection (f) (or, in a cases based on
- 3 compelling personal circumstances scholarships of a pro-
- 4 rated lesser dollar amount to eligible older individuals who
- 5 have completed not less than 300 hours, but less than 600
- 6 hours, of such volunteer services in such 12-month pe-
- 7 riod).
- 8 "(d) Limitation.—Not more than 1 scholarship may
- 9 be awarded under this section to a particular eligible older
- 10 individual in any 5-year period.
- 11 "(e) Criteria and Priorities for Awarding
- 12 Scholarships.—For purposes of carrying out this sec-
- 13 tion, the Assistant Secretary shall establish by rule criteria
- 14 and priorities to be applied by grant recipients in awarding
- 15 scholarships under this section to eligible older individuals.
- 16 "(f) Volunteer Services.—The Assistant Sec-
- 17 retary shall determine which types of volunteer services
- 18 (including tutoring and mentoring in a school setting, an
- 19 afterschool setting, or another community-based edu-
- 20 cational setting, and assisting individuals with special
- 21 needs to continue living independently) are appropriate for
- 22 purposes of satisfying the service requirements specified
- 23 in subsection (c).
- 24 "(g) Use of Scholarships.—A scholarship award-
- 25 ed under this section may be used only—

1	"(1) by the older individual who receives such
2	scholarship or by any individual designated by such
3	older individual;
4	"(2) for the payment of qualified tuition and
5	related expenses, as defined in section 117 of the In-
6	ternal Revenue Code of 1986 (26 U.S.C. 117), and
7	in accordance with conditions established by the As-
8	sistant Secretary by rule; and
9	"(3) before the expiration of the 7-year period
10	beginning on the date of receipt of such scholarship.
11	"(h) Authorization of Appropriations.—There
12	are authorized to be appropriated to carry out this section
13	\$20,000,000 for fiscal year 2007 and such sums as may
14	be necessary for fiscal years 2008 through 2011.".
