- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Fort McDowell Indian
- 5 Community Water Rights Settlement Revision Act of
- 6 2006".
- 7 SEC. 2. DEFINITIONS.
- 8 In this Act:

1	(1) Fort mcdowell water rights settle-
2	MENT ACT.—The term "Fort McDowell Water
3	Rights Settlement Act" means the Fort McDowell
4	Indian Community Water Rights Settlement Act of
5	1990 (Public Law 101–628; 104 Stat. 4480).
6	(2) Nation.—The term "Nation" means the
7	Fort McDowell Yavapai Nation, formerly known as
8	the "Fort McDowell Indian Community".
9	(3) Secretary.—The term "Secretary" means
10	the Secretary of the Interior.
11	SEC. 3. CANCELLATION OF REPAYMENT OBLIGATION.
12	(a) CANCELLATION OF OBLIGATION.—The obligation
13	of the Nation to repay the loan made under section 408(e)
14	of the Fort McDowell Water Rights Settlement Act (104
15	Stat. 4489) is cancelled.
16	(b) Effect of Act.—
17	(1) Rights of Nation under fort
18	MCDOWELL WATER RIGHTS SETTLEMENT ACT.—
19	(A) In general.—Except as provided in
20	subparagraph (B), nothing in this Act alters or
21	affects any right of the Nation under the Fort
22	McDowell Water Rights Settlement Act.
23	(B) Exception.—The cancellation of the
24	repayment obligation under subsection (a) shall
25	be considered—

1	(i) to fulfill all conditions required to
2	achieve a full and final settlement of all
3	claims to water rights or injuries to water
4	rights under the Fort McDowell Water
5	Rights Settlement Act; and
6	(ii) to relieve the Secretary of any re-
7	sponsibility or obligation to obtain mitiga-
8	tion property or develop additional farm
9	acreage under section 410 the Fort
10	McDowell Water Rights Settlement Act
11	(104 Stat. 4490).
12	(2) Eligibility for services and bene-
13	FITS.—Nothing in this Act alters or affects the eligi-
14	bility of the Nation or any member of the Nation for
15	any service or benefit provided by the Federal Gov-
16	ernment to federally recognized Indian tribes or
