AN ACT

To establish the Upper Housatonic Valley National Heritage Area.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,

1 SECTION 1. SHORT TITLE.

2	This Act may be cited as the "Upper Housatonic Val-
3	ley National Heritage Area Act".
4	SEC. 2. FINDINGS AND PURPOSES.
5	(a) Findings.—Congress finds the following:
6	(1) The upper Housatonic Valley, encompassing
7	29 towns in the hilly terrain of western Massachu-
8	setts and northwestern Connecticut, is a singular
9	geographical and cultural region that has made sig-
10	nificant national contributions through its literary,
11	artistic, musical, and architectural achievements, its
12	iron, paper, and electrical equipment industries, and
13	its scenic beautification and environmental conserva-
14	tion efforts.
15	(2) The upper Housatonic Valley has 139 prop-
16	erties and historic districts listed on the National
17	Register of Historic Places, including—
18	(A) five National Historic Landmarks—
19	(i) Edith Wharton's home, The
20	Mount, Lenox, Massachusetts;
21	(ii) Herman Melville's home, Arrow-
22	head, Pittsfield, Massachusetts;
23	(iii) W.E.B. DuBois' Boyhood Home-
24	site, Great Barrington, Massachusetts;
25	(iv) Mission House, Stockbridge, Mas-
26	sachusetts; and

1	(v) Crane and Company Old Stone
2	Mill Rag Room, Dalton, Massachusetts;
3	and
4	(B) four National Natural Landmarks—
5	(i) Bartholomew's Cobble, Sheffield,
6	Massachusetts, and Salisbury, Connecticut;
7	(ii) Beckley Bog, Norfolk, Con-
8	necticut;
9	(iii) Bingham Bog, Salisbury, Con-
10	necticut; and
11	(iv) Cathedral Pines, Cornwall, Con-
12	necticut.
13	(3) Writers, artists, musicians, and vacationers
14	have visited the region for more than 150 years to
15	enjoy its scenic wonders, making it one of the coun-
16	try's leading cultural resorts.
17	(4) The upper Housatonic Valley has made sig-
18	nificant national cultural contributions through such
19	writers as Herman Melville, Nathaniel Hawthorne,
20	Edith Wharton, and W.E.B. DuBois, artists Daniel
21	Chester French and Norman Rockwell, and the per-
22	forming arts centers of Tanglewood, Music Moun-
23	tain, Norfolk (Connecticut) Chamber Music Festival,
24	Jacob's Pillow, and Shakespeare & Company.

- 1 (5) The upper Housatonic Valley is noted for 2 its pioneering achievements in the iron, paper, and 3 electrical generation industries and has cultural re-4 sources to interpret those industries.
 - (6) The region became a national leader in scenic beautification and environmental conservation efforts following the era of industrialization and deforestation and maintains a fabric of significant conservation areas including the meandering Housatonic River.
 - (7) Important historical events related to the American Revolution, Shays' Rebellion, and early civil rights took place in the upper Housatonic Valley.
 - (8) The region had an American Indian presence going back 10,000 years and Mohicans had a formative role in contact with Europeans during the seventeenth and eighteenth centuries.
 - (9) The Upper Housatonic Valley National Heritage Area has been proposed in order to heighten appreciation of the region, preserve its natural and historical resources, and improve the quality of life and economy of the area.
- 24 (b) Purposes.—The purposes of this Act are as follows:

- 1 (1) To establish the Upper Housatonic Valley
 2 National Heritage Area in the State of Connecticut
 3 and the Commonwealth of Massachusetts.
 - (2) To implement the national heritage area alternative as described in the document entitled "Upper Housatonic Valley National Heritage Area Feasibility Study, 2003".
 - (3) To provide a management framework to foster a close working relationship with all levels of government, the private sector, and the local communities in the upper Housatonic Valley region to conserve the region's heritage while continuing to pursue compatible economic opportunities.
 - (4) To assist communities, organizations, and citizens in the State of Connecticut and the Commonwealth of Massachusetts in identifying, preserving, interpreting, and developing the historical, cultural, scenic, and natural resources of the region for the educational and inspirational benefit of current and future generations.
- 21 SEC. 3. DEFINITIONS.
- In this Act:

23 (1) Heritage Area.—The term "Heritage 24 Area" means the Upper Housatonic Valley National 25 Heritage Area, established in section 4.

1	(2) Management entity.—The term "Man-				
2	agement Entity" means the management entity fo				
3	the Heritage Area designated by section 4(d).				
4	(3) Management Plan.—The term "Manage-				
5	ment Plan" means the management plan for the				
6	Heritage Area specified in section 6.				
7	(4) Map.—The term "map" means the map en-				
8	titled "Boundary Map Upper Housatonic Valley Na-				
9	tional Heritage Area", numbered P17/80,000, and				
10	dated February 2003.				
11	(5) Secretary.—The term "Secretary" means				
12	the Secretary of the Interior.				
13	(6) STATE.—The term "State" means the State				
14	of Connecticut and the Commonwealth of Massachu-				
15	setts.				
16	SEC. 4. UPPER HOUSATONIC VALLEY NATIONAL HERITAGE				
17	AREA.				
18	(a) ESTABLISHMENT.—There is established the				
19	Upper Housatonic Valley National Heritage Area.				
20	(b) Boundaries.—The Heritage Area shall be com-				
21	prised of—				
22	(1) part of the Housatonic River's watershed,				
23	which extends 60 miles from Lanesboro, Massachu-				
24	setts to Kent. Connecticut:				

1	(2) the towns of Canaan, Colebrook, Cornwall,					
2	Kent, Norfolk, North Canaan, Salisbury, Sharon,					
3	and Warren in Connecticut; and					
4	(3) the towns of Alford, Becket, Dalton,					
5	Egremont, Great Barrington, Hancock, Hinsdale,					
6	Lanesboro, Lee, Lenox, Monterey, Mount Wash					
7	ington, New Marlboro, Pittsfield, Richmond, Shef-					
8	field, Stockbridge, Tyringham, Washington, and					
9	West Stockbridge in Massachusetts.					
10	(c) AVAILABILITY OF MAP.—The map shall be on file					
11	and available for public inspection in the appropriate of-					
12	fices of the National Park Service, Department of the In-					
13	terior.					
14	(d) Management Entity.—The Upper Housatonic					
15	Valley National Heritage Area, Inc. shall be the manage-					
16	ment entity for the Heritage Area.					
17	SEC. 5. AUTHORITIES, PROHIBITIONS, AND DUTIES OF THE					
18	MANAGEMENT ENTITY.					
19	(a) Duties of the Management Entity.—To fur-					
20	ther the purposes of the Heritage Area, the management					
21	entity shall—					
22	(1) prepare and submit a management plan for					
23	the Heritage Area to the Secretary in accordance					
24	with section 6;					

1	(2) assist units of local government, regional
2	planning organizations, and nonprofit organizations
3	in implementing the approved management plan
4	by—
5	(A) carrying out programs and projects
6	that recognize, protect and enhance important
7	resource values within the Heritage Area;
8	(B) establishing and maintaining interpre-
9	tive exhibits and programs within the Heritage
10	Area;
11	(C) developing recreational and educational
12	opportunities in the Heritage Area;
13	(D) increasing public awareness of and ap-
14	preciation for natural, historical, scenic, and
15	cultural resources of the Heritage Area;
16	(E) protecting and restoring historic sites
17	and buildings in the Heritage Area that are
18	consistent with heritage area themes;
19	(F) ensuring that signs identifying points
20	of public access and sites of interest are posted
21	throughout the Heritage Area; and
22	(G) promoting a wide range of partner-
23	ships among governments, organizations and in-
24	dividuals to further the purposes of the Herit-
25	age Area;

- 1 (3) consider the interests of diverse units of 2 government, businesses, organizations and individ-3 uals in the Heritage Area in the preparation and im-4 plementation of the management plan;
 - (4) conduct meetings open to the public at least semi-annually regarding the development and implementation of the management plan;
 - (5) submit an annual report to the Secretary for any fiscal year in which the management entity receives Federal funds under this Act, setting forth its accomplishments, expenses, and income, including grants to any other entities during the year for which the report is made;
 - (6) make available for audit for any fiscal year in which it receives Federal funds under this Act, all information pertaining to the expenditure of such funds and any matching funds, and require in all agreements authorizing expenditures of Federal funds by other organizations, that the receiving organizations make available for such audit all records and other information pertaining to the expenditure of such funds; and
 - (7) encourage by appropriate means economic development that is consistent with the purposes of the Heritage Area.

1	(b) AUTHORITIES.—The management entity may, for				
2	the purposes of preparing and implementing the manag				
3	ment plan for the Heritage Area, use Federal funds mad				
4	available through this Act to—				
5	(1) make grants to the State of Connecticut				
6	and the Commonwealth of Massachusetts, their po				
7	litical subdivisions, nonprofit organizations and other				
8	persons;				
9	(2) enter into cooperative agreements with or				
10	provide technical assistance to the State of Con-				
11	necticut and the Commonwealth of Massachusetts,				
12	their subdivisions, nonprofit organizations, and other				
13	interested parties;				
14	(3) hire and compensate staff, which shall in-				
15	clude individuals with expertise in natural, cultural,				
16	and historical resources protection, and heritage pro-				
17	gramming;				
18	(4) obtain money or services from any source				
19	including any that are provided under any other				
20	Federal law or program;				
21	(5) contract for goods or services; and				
22	(6) undertake to be a catalyst for any other ac-				
23	tivity that furthers the purposes of the Heritage				
24	Area and is consistent with the approved manage-				

ment plan.

1	(e) Prohibitions on the Acquisition of Real
2	PROPERTY.—The management entity may not use Fed-
3	eral funds received under this Act to acquire real property,
4	but may use any other source of funding, including other
5	Federal funding outside this authority, intended for the
6	acquisition of real property.
7	SEC. 6. MANAGEMENT PLAN.
8	(a) In General.—The management plan for the
9	Heritage Area shall—
10	(1) include comprehensive policies, strategies
11	and recommendations for conservation, funding,
12	management and development of the Heritage Area;
13	(2) take into consideration existing State, coun-
14	ty, and local plans in the development of the man-
15	agement plan and its implementation;
16	(3) include a description of actions that govern-
17	ments, private organizations, and individuals have
18	agreed to take to protect the natural, historical and
19	cultural resources of the Heritage Area;
20	(4) specify the existing and potential sources of
21	funding to protect, manage, and develop the Herit-
22	age Area in the first 5 years of implementation;
23	(5) include an inventory of the natural, histor-
24	ical, cultural, educational, scenic, and recreational
25	resources of the Heritage Area related to the themes

- 1 of the Heritage Area that should be preserved, re-2 stored, managed, developed, or maintained;
- 3 (6) describe a program of implementation for the management plan including plans for resource 5 protection, restoration, construction, and specific 6 commitments for implementation that have been 7 made by the management entity or any government, 8 organization, or individual for the first 5 years of 9 implementation; and
- 10 (7) include an interpretive plan for the Heritage 11 Area.
 - (b) DEADLINE AND TERMINATION OF FUNDING.—
 - (1) DEADLINE.—The management entity shall submit the management plan to the Secretary for approval within 3 years after funds are made available for this Act.
- 17 (2) TERMINATION OF FUNDING.—If the man-18 agement plan is not submitted to the Secretary in 19 accordance with this subsection, the management en-20 tity shall not qualify for Federal funding under this Act until such time as the management plan is sub-22 mitted to the Secretary.
- 23 SEC. 7. DUTIES AND AUTHORITIES OF THE SECRETARY.
- 24 (a) TECHNICAL AND FINANCIAL ASSISTANCE.—The Secretary may, upon the request of the management enti-

1	ty, provide technical assistance on a reimbursable or non-				
2	reimbursable basis and financial assistance to the Herit-				
3	age Area to develop and implement the approved manage-				
4	ment plan. The Secretary is authorized to enter into coop-				
5	erative agreements with the management entity and other				
6	public or private entities for this purpose. In assisting the				
7	Heritage Area, the Secretary shall give priority to actions				
8	that in general assist in—				
9	(1) conserving the significant natural, histor-				
10	ical, cultural, and scenic resources of the Heritage				
11	Area; and				
12	(2) providing educational, interpretive, and rec-				
13	reational opportunities consistent with the purposes				
14	of the Heritage Area.				
15	(b) Approval and Disapproval of Management				
16	Plan.—				
17	(1) In general.—The Secretary shall approve				
18	or disapprove the management plan not later than				
19	90 days after receiving the management plan.				
20	(2) Criteria for approval.—In determining				
21	the approval of the management plan, the Secretary				
22	shall consider whether—				
23	(A) the management entity is representa-				
24	tive of the diverse interests of the Heritage				
25	Area, including governments, natural and his-				

- toric resource protection organizations, educational institutions, businesses, and recreational organizations;
 - (B) the management entity has afforded adequate opportunity, including public hearings, for public and governmental involvement in the preparation of the management plan;
 - (C) the resource protection and interpretation strategies contained in the management plan, if implemented, would adequately protect the natural, historical, and cultural resources of the Heritage Area; and
 - (D) the management plan is supported by the appropriate State and local officials whose cooperation is needed to ensure the effective implementation of the State and local aspects of the management plan.
 - (3) ACTION FOLLOWING DISAPPROVAL.—If the Secretary disapproves the management plan, the Secretary shall advise the management entity in writing of the reasons therefore and shall make recommendations for revisions to the management plan. The Secretary shall approve or disapprove a proposed revision within 60 days after the date it is submitted.

1 (4) APPROVAL OF AMENDMENTS.—Substantial 2 amendments to the management plan shall be re-3 viewed by the Secretary and approved in the same 4 manner as provided for the original management 5 plan. The management entity shall not use Federal 6 funds authorized by this Act to implement any 7 amendments until the Secretary has approved the 8 amendments.

9 SEC. 8. DUTIES OF OTHER FEDERAL AGENCIES.

- 10 Any Federal agency conducting or supporting activi-11 ties directly affecting the Heritage Area shall—
- 12 (1) consult with the Secretary and the manage-13 ment entity with respect to such activities;
 - (2) cooperate with the Secretary and the management entity in carrying out their duties under this Act and, to the maximum extent practicable, coordinate such activities with the carrying out of such duties; and
 - (3) to the maximum extent practicable, conduct or support such activities in a manner which the management entity determines will not have an adverse effect on the Heritage Area.

1	SEC. 9. REQUIREMENTS FOR INCLUSION OF PRIVATE					
2	PROPERTY.					
3	(a) Notification and Consent of Property					
4	OWNERS REQUIRED.—No privately owned property shall					
5	be preserved, conserved, or promoted by the management					
6	plan for the Heritage Area until the owner of that private					
7	property has been notified in writing by the management					
8	entity and has given written consent for such preservation,					
9	conservation, or promotion to the management entity.					
10	(b) Landowner Withdraw.—Any owner of private					
11	property included within the boundary of the Heritage					
12	Area shall have their property immediately removed from					
13	the boundary by submitting a written request to the man-					
14	agement entity.					
15	SEC. 10. PRIVATE PROPERTY PROTECTION.					
16	(a) Access to Private Property.—Nothing in					
17	this Act shall be construed to—					
18	(1) require any private property owner to allow					
19	public access (including Federal, State, or local gov-					
20	ernment access) to such private property; or					
21	(2) modify any provision of Federal, State, or					
22	local law with regard to public access to or use of					
23	private property.					
24	(b) Liability.—Designation of the Heritage Area					
25	shall not be considered to create any liability, or to have					
26	any effect on any liability under any other law, of any pri-					

- 1 vate property owner with respect to any persons injured
- 2 on such private property.
- 3 (c) Recognition of Authority to Control Land
- 4 Use.—Nothing in this Act shall be construed to modify
- 5 the authority of Federal, State, or local governments to
- 6 regulate land use.
- 7 (d) Participation of Private Property Owners
- 8 IN HERITAGE AREA.—Nothing in this Act shall be con-
- 9 strued to require the owner of any private property located
- 10 within the boundaries of the Heritage Area to participate
- 11 in or be associated with the Heritage Area.
- 12 (e) Effect of Establishment.—The boundaries
- 13 designated for the Heritage Area represent the area within
- 14 which Federal funds appropriated for the purpose of this
- 15 Act may be expended. The establishment of the Heritage
- 16 Area and its boundaries shall not be construed to provide
- 17 any nonexisting regulatory authority on land use within
- 18 the Heritage Area or its viewshed by the Secretary, the
- 19 National Park Service, or the management entity.

20 SEC. 11. AUTHORIZATION OF APPROPRIATIONS.

- 21 (a) In General.—There is authorized to be appro-
- 22 priated for the purposes of this Act not more than
- 23 \$1,000,000 for any fiscal year. Not more than a total of
- 24 \$10,000,000 may be appropriated for the Heritage Area
- 25 under this Act.

- 1 (b) MATCHING FUNDS.—Federal funding provided
- 2 under this Act may not exceed 50 percent of the total cost
- 3 of any assistance or grant provided or authorized under
- 4 this Act.
- 5 SEC. 12. SUNSET.
- 6 The authority of the Secretary to provide assistance
- 7 under this Act shall terminate on the day occurring 15
- 8 years after the date of the enactment of this Act.
