7 (a) IN GENERAL.—Notwithstanding subsections (a) 8 and (b) of section 201 of the Immigration and Nationality 9 Act, Kadiatou Diallo, Laouratou Diallo, Ibrahima Diallo, Abdoul Diallo, Mamadou Bobo Diallo, Mamadou Pathe 10 11 Diallo, Fatoumata Traore Diallo, Sankarela Diallo, and Marliatou Bah shall each be eligible for issuance of an 12 13 immigrant visa or for adjustment of status to that of an 14 alien lawfully admitted for permanent residence upon filing an application for issuance of an immigrant visa under 15 16 section 204 of such Act or for adjustment of status to lawful permanent resident. 17

18 (b) ADJUSTMENT OF STATUS.—If Kadiatou Diallo, 19 Laouratou Diallo, Ibrahima Diallo, Abdoul Diallo, 20Bobo Diallo, Mamadou Mamadou Pathe Diallo, 21 Fatoumata Traore Diallo, Sankarela Diallo, or Marliatou 22 Bah enters the United States before the filing deadline 23 specified in subsection (c), he or she shall be considered 24 to have entered and remained lawfully and shall, if otherwise eligible, be eligible for adjustment of status under 25

section 245 of the Immigration and Nationality Act as of
the date of the enactment of this Act.

3 (c) DEADLINE FOR APPLICATION AND PAYMENT OF 4 FEES.—Subsections (a) and (b) shall apply only if the ap-5 plication for issuance of an immigrant visa or the application for adjustment of status is filed with appropriate fees 6 7 within 2 years after the date of the enactment of this Act. (d) REDUCTION OF IMMIGRANT VISA NUMBER.-8 9 Upon the granting of an immigrant visa or permanent res-10 idence to Kadiatou Diallo, Laouratou Diallo, Ibrahima Diallo, Abdoul Diallo, Mamadou Bobo Diallo, Mamadou 11 12 Pathe Diallo, Fatoumata Traore Diallo, Sankarela Diallo, 13 and Marliatou Bah, the Secretary of State shall instruct the proper officer to reduce by 9, during the current or 14 15 next following fiscal year, the total number of immigrant visas that are made available to natives of the country of 16 17 the aliens' birth under section 203(a) of the Immigration and Nationality Act or, if applicable, the total number of 18 19 immigrant visas that are made available to natives of the country of the aliens' birth under section 202(e) of such 20 21 Act.
