A BILL

To establish reporting requirements relating to funds made available for military operations in Iraq or the reconstruction of Iraq and for military operations in Afghanistan or the reconstruction of Afghanistan, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,

1 SECTION 1. SHORT TITLE.

2	This Act may be cited as the "War Funding Account-
3	ability Act".
4	SEC. 2. REPORTING REQUIREMENTS RELATING TO IRAQ.
5	(a) Initial Report.—Not later than 30 days after
6	the date of the enactment of an Act (enacted after the
7	date of the enactment of this Act) making appropriations
8	for military operations in Iraq or for the reconstruction
9	of Iraq, the President shall prepare and transmit to Con-
10	gress a report that contains a detailed description of
11	United States goals with respect to such military oper-
12	ations or reconstruction efforts, including—
13	(1) a description of the purposes for which
14	amounts will be made available under the Act;
15	(2) a plan for the security of Iraq, including a
16	plan to ensure participation by the armed forces of
17	additional countries in Iraq;
18	(3) a plan for the reconstruction of Iraq;
19	(4) a description of progress toward the Decem-
20	ber 15, 2005, elections for a permanent government
21	of Iraq; and
22	(5) a description of United States efforts to ob-
23	tain financial support for Iraq from other countries
24	and international financial institutions.
25	(b) Subsequent Reports.—Not later than 90 days

26 after the date on which the initial report is transmitted

1	under subsection (a), and every 90 days thereafter until
2	all amounts made available under the Act described in
3	such subsection are obligated and expended, the President
4	shall prepare and transmit to Congress a report that con-
5	tains a detailed description of programs, projects, and ac-
6	tivities carried out using amounts available under such Act
7	that are obligated or expended during the previous 90-day
8	period, including—
9	(1) a description of the specific allocation of
10	funds to meet the purposes described in subsection
11	(a)(1);
12	(2) an update on progress made to achieve the
13	goals described in paragraphs (2) through (5) of
14	subsection (a), including—
15	(A) a description of progress made to train
16	the military and police of Iraq and the Iraq
17	National Guard and to reform the Iraqi judicial
18	system;
19	(B) a description of efforts to rebuild the
20	electric power infrastructure, water and sewage
21	services, and telecommunications structure in
22	Iraq; and
23	(C) a description of efforts to repair and
24	upgrade Iraqi hospitals, clinics, public build-
25	ings, and roadways and bridges;

- (3) a description of efforts to promote economic
 development in Iraq;
- (4) in the case of a contract entered into by the
 United States relating to military operations in Iraq
 or the reconstruction of Iraq, the name of the contractor and a description of the process by which the
 contract was awarded;
 - (5) a description of efforts to provide adequate deployment rotation and other relief for United States troops serving in Iraq, including efforts to provide improved protection for the living quarters and dining facilities of such United States troops; and
- 14 (6) an assessment of the remaining needs with 15 respect to military operations in Iraq and the recon-16 struction of Iraq, including a description of addi-17 tional funding required to meet these needs, if nec-18 essary.

- 21 (a) Initial Report.—Not later than 30 days after
- 22 the date of the enactment of an Act (enacted after the
- 23 date of the enactment of this Act) making appropriations
- 24 for military operations in Afghanistan or for the recon-
- 25 struction of Afghanistan, the President shall prepare and

- 1 transmit to Congress a report that contains a detailed de-
- 2 scription of United States goals with respect to such mili-

- 4 (1) a description of the purposes for which 5 amounts will be made available under the Act;

- 11 (4) a description of preparations for the April 12 2005 parliamentary elections in Afghanistan; and
- 13 (5) a description of United States efforts to ob-14 tain financial support for Afghanistan from other 15 countries and international financial institutions.
- 16 (b) Subsequent Reports.—Not later than 90 days
- 17 after the date on which the initial report is transmitted
- 18 under subsection (a), and every 90 days thereafter until
- 19 all amounts made available under the Act described in
- 20 such subsection are obligated and expended, the President
- 21 shall prepare and transmit to Congress a report that con-

19	(4) in the case of a contract entered into by the
20	United States relating to military operations in Af-
21	ghanistan or the reconstruction of Afghanistan, the
22	name of the contractor and a description of the
23	process by which the contract was awarded;
24	(5) a description of efforts to provide adequate
25	deployment rotation and other relief for United

- 1 States troops serving in Afghanistan, including ef-
- 2 forts to provide improved protection for the living
- quarters and dining facilities of such United States
- 4 troops; and
- 5 (6) an assessment of the remaining needs with

10 SEC. 4. LIMITATION ON AVAILABILITY OF FUNDS FOR IRAQ

- 11 AND AFGHANISTAN.
- 12 (a) Limitation on Funds for Iraq.—Notwith-
- 13 standing any other provision of law, if the requirement to
- 14 transmit an initial report under section 2(a) is not met,
- 15 or the requirement to transmit a subsequent report under
- 16 section 2(b) is not met, then amounts for the reconstruc-
- 17 tion of Iraq available under an Act described in section
- 18 2 with respect to which the report relates, or available
- 19 under any other provision of law, that are unobligated or
- 20 unexpended may not be obligated or expended (as the case
- 21 may be) until the report is transmitted to Congress.
- 22 (b) Limitation on Funds for Afghanistan.—
- 23 Notwithstanding any other provision of law, if the require-
- 24 ment to transmit an initial report under section 3(a) is
- 25 not met, or the requirement to transmit a subsequent re-

- 1 port under section 3(b) is not met, then amounts for the
- 2 reconstruction of Afghanistan available under an Act de-
- 3 scribed in section 3 with respect to which the report re-
- 4 lates, or available under any other provision of law, that
- 5 are unobligated or unexpended may not be obligated or
- 6 expended (as the case may be) until the report is trans-

7 mitted to Congress.
