A BILL

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. MILITARY RETIREMENT CREDIT FOR CERTAIN**
2 **SERVICE PERFORMED BY MEMBERS OF THE**
3 **NATIONAL GUARD ARISING FROM THE TER-**
4 **RORIST ATTACKS OF SEPTEMBER 11, 2001.**

5 (a) RETIREMENT POINTS.—Section 12732(a)(2)(A)
6 of title 10, United States Code, is amended—

7 (1) by striking “or” at the end of clause (i);

8 (2) by inserting “or” at the end of clause (ii);

9 and

10 (3) by inserting after clause (ii) the following
11 new clause:

12 “(iii) full-time service under title 32
13 while performing duty to which the person
14 was ordered immediately following the ter-
15 rorist attacks on the United States of Sep-
16 tember 11, 2001, in a county designated
17 by the President by reason of such attacks
18 as a Federal disaster area, while such serv-
19 ice continued without a break in service;”.

20 (b) COMPUTATION OF RETIREMENT.—Section 12733
21 of such title is amended by adding at the end the following
22 new paragraph:

23 “(6) The person’s days of active service under
24 title 32 described in clause (iii) of section
25 12732(a)(2)(A) of this title.”.

1 (c) EFFECTIVE DATE.—The amendments made by
2 this section shall apply in the case of any person who be-
3 came entitled to retired pay under chapter 1223 of title
4 10, United States Code, between September 11, 2001, and
5 the date of the enactment of this Act as if such amend-
6 ments had been in effect on the day before the effective
7 date of such person’s entitlement to receive such retired
8 pay.
