- 2 rule XXII of Rules of the House of Representatives is
- 3 amended by inserting "and shall contain the estimate of
- 4 costs described in section 308(a)(2) of the Congressional
- 5 Budget Act of 1974" before the period.

- 1 (b) Clause 7 of rule XXII of Rules of the House of
- 2 Representatives is amended by adding at the end the fol-
- 3 lowing new paragraph:
- 4 "(f) It shall not be in order to consider a conference
- 5 report unless it contains an estimate of costs as described
- 6 in the last sentence of paragraph (e).".

- 9 Sec. 2. Clause 10 of rule XX of the Rules of the
- 10 House of Representatives is amended by inserting "au-
- 11 thorizing or providing new budget authority of not less
- 12 than \$50,000,000" before "making general appropria-
- 13 tions" and by adding at the end the following new sen-
- 14 tence: "The Speaker may not entertain a unanimous con-
- 15 sent request or motion to suspend this clause.".

- 18 are amended by repealing rule XXVII (relating to the stat-
- 19 utory limit on public debt) and by redesignating rule

- 22 REPORTS
- SEC. 4. In rule XIII of the Rules of the House of
- 24 Representatives, clause 6(a) is amended by striking "the
- 25 same day" and inserting "the same calendar day or less
- 26 than 17 hours after that".

1	TWO-THIRDS REQUIREMENT FOR CERTAIN WAIVERS

3	Sec. 5. (a) Two-Thirds Requirement.—Clause
4	6(c) of rule XIII of the Rules of the House of Representa-
5	tives is amended by striking the period and inserting a
6	semicolon at the end of subparagraph (2) and by adding
7	at the end the following new subparagraph:
8	"(3) a rule or order which would waive the lay-
9	over requirement of clause 8 of rule XXII con-
10	cerning the availability of reports, would waive the
11	three-day layover requirement or the three-day
12	Internet availability requirement of clause 4(a)(1) of
13	this rule or of clause 8(a)(1) of rule XXII, or would
14	waive the scope requirement of the last sentence of
15	clause 9 of rule XXII by a vote of less than two-
16	thirds of the Members voting, a quorum being
17	present.".
18	(b) Conforming Amendment.—Clause 6(a) of rule
19	XIII of the Rules of the House of Representatives is
20	amended by striking subparagraph (2), by inserting "or"
21	after the semicolon at the end of subparagraph (1), and

25	SEC. 6. (a) Clause 4(a)(1) of rule XIII of the Rules
26	of the House of Representatives is amended by inserting

- 2 derlying measure or matter has been made available by
- 3 the Committee on Rules on its Internet site" before the
- 4 period.
- 5 (b) Clause 8(a)(1)(A) of rule XXII of the Rules of
- 6 the House of Representatives is amended by inserting
- 7 "and until the third such calendar day on which such con-
- 8 ference report and joint explanatory statement have been
- 9 made available by the standing committee of the House
- 10 with subject matter jurisdiction over the underlying legis-
- 11 lation on its Internet site" before the semicolon.
- WRITTEN JUSTIFICATION FOR EARMARKS
- 13 SEC. 7. Clause 2 of rule XXI of the Rules of the
- 14 House of Representatives is amended by adding at the end
- 15 the following new paragraph:
- 16 "(g) The report that accompanies any general appro-
- 17 priation bill shall contain a separate written justification
- 18 for each earmark contained in such bill or report.".
- 19 MANDATORY OVERSIGHT
- SEC. 8. Clause 2(d) of rule X of the Rules of the
- 21 House of Representatives is amended by adding at the end
- 22 the following new subparagraph:
- 23 "(3) Not later than July 1 in the first session of a
- 24 Congress, and at six-month intervals thereafter during
- 25 that Congress, each committee shall submit reports to the
- 26 Speaker and the minority leader respecting the commit-

- 1 tee's compliance with its oversight plan. Committees shall
- 2 make these reports available to the public.".
