Requesting the President and directing the Secretary of Defense to transmit to the House of Representatives not later than 14 days after the date of the adoption of this resolution all documents in the possession of the President and Secretary of Defense relating to communications with officials of the United Kingdom relating to the policy of the United States with respect to Iraq.

1 *Resolved*, That not later than 14 days after the date
2 of the adoption of this resolution—

3 (1) the President is requested to transmit to
4 the House of Representatives all documents, includ-
5 ing telephone and electronic mail records, logs, cal-
6 endars, minutes, and memos, in the possession of
7 the President relating to communications with offi-
8 cials of the United Kingdom from January 1, 2001,
9 to March 19, 2003, relating to the policy of the
10 United States with respect to Iraq, including any
11 discussions or communications between the Presi-
12 dent, then National Security Advisor Condoleezza
13 Rice, or other Administration officials and officials
14 of the United Kingdom; and

15 (2) the Secretary of Defense is directed to
16 transmit to the House of Representatives all docu-
17 ments, including telephone and electronic mail
18 records, logs, calendars, minutes, and memos, in the
19 possession of the Secretary relating to communica-
20 tions with officials of the United Kingdom from Jan-
21 uary 1, 2001, to March 19, 2003, relating to the
22 policy of the United States with respect to Iraq, in-
23 cluding any discussions or communications between
24 any Defense Department official, including Under
25 Secretary of Defense for Policy Douglas J. Feith

1 and Under Secretary of Defense for Intelligence Dr.
2 Stephen A. Cambone, and officials of the United
3 Kingdom.
