Requesting the President of the United States and directing the Secretary of State to provide to the House of Representatives certain documents in their possession relating to United States policies under the United Nations Convention Against Torture and Other Cruel, Inhuman or Degrading Treatment or Punishment and the Geneva Conventions.

1 Resolved, That the President of the United States is 2 requested and the Secretary of State is directed to provide 3 to the House of Representatives, not later than 14 days after the date of the adoption of this resolution— 4 5 (1) all documents, memoranda, and advisory 6 legal opinions in the possession of the President or 7 the Secretary of State, respectively, from the De-8 partment of State provided to the Executive Office 9 of the President since September 11, 2001, relating 10 to— 11 (A) United States policies under 12 United Nations Convention Against Torture 13 and Other Cruel, Inhuman or Degrading Treatment or Punishment (1465 U.N.T.S. 113) to-14 15 ward individuals captured by or transferred to 16 the United States or detained in United States 17 custody as part of the Global War on Terror; 18 and 19 (B) United States policies under the Gene-20 va Conventions (6 U.S.T. 3114, 6 U.S.T. 3217, 21 6 U.S.T. 3316, and 6 U.S.T. 3516) toward in-22 dividuals captured by or transferred to the 23 United States or detained in United States cus-24 tody as part of the Global War on Terror; and
