RESOLUTION

Requesting the President and directing the Secretary of Defense to transmit to the House of Representatives all information in the possession of the President or the Secretary of Defense relating to the collection of intel-

ligence information pertaining to persons inside the United States without obtaining court-ordered warrants authorizing the collection of such information and relating to the policy of the United States with respect to the gathering of counterterrorism intelligence within the United States.

1 *Resolved*, That—

2 (1) the President is requested to transmit to
3 the House of Representatives, not later than 14 days
4 after the date of the adoption of this resolution, all
5 documents, including telephone and electronic mail
6 records, logs, calendars, minutes, and memos, in the
7 possession of the President relating to—

8 (A) the scope of the activities undertaken
9 by the Department of Defense, the Counter-
10 intelligence Field Activity, or any related agency
11 with regard to Threat and Local Observation
12 Notice reports (TALONs); and

13 (B) the legal authority upon which surveil-
14 lance by the National Security Agency or the
15 Department of Defense of persons inside the
16 United States and the gathering of
17 counterterrorism intelligence within the United
18 States without obtaining court-ordered warrants
19 is based; and

1 (2) the Secretary of Defense is directed to
2 transmit to the House of Representatives, not later
3 than 14 days after the date of the adoption of this
4 resolution, all documents, including telephone and
5 electronic mail records, logs, calendars, minutes,
6 memos, and records of internal discussions, in the
7 possession of the Secretary relating to—

8 (A) the scope of the activities undertaken
9 by the Department of Defense, the Counter-
10 intelligence Field Activity, or any related agen-
11 cy with regard to Threat and Local Observation
12 Notice reports; and

13 (B) the legal authority upon which surveil-
14 lance by the National Security Agency or the
15 Department of Defense of persons inside the
16 United States and the gathering of
17 counterterrorism intelligence within the United
18 States without obtaining court-ordered warrants
19 is based.
