## RESOLUTION

Providing for consideration of the bill (H.R. 5576) making appropriations for the Departments of Transportation, Treasury, and Housing and Urban Development, the Judiciary, District of Columbia, and independent agencies for the fiscal year ending September 30, 2007, and for other purposes.

- 1       *Resolved*, That at any time after the adoption of this
- 2 resolution the Speaker may, pursuant to clause 2(b) of
- 3 rule XVIII, declare the House resolved into the Committee

1 of the Whole House on the state of the Union for consider-  
2 ation of the bill (H.R. 5576) making appropriations for  
3 the Departments of Transportation, Treasury, and Hous-  
4 ing and Urban Development, the Judiciary, District of Co-  
5 lumbia, and independent agencies for the fiscal year end-  
6 ing September 30, 2007, and for other purposes. The first  
7 reading of the bill shall be dispensed with. All points of  
8 order against consideration of the bill are waived. General  
9 debate shall be confined to the bill and shall not exceed  
10 one hour equally divided and controlled by the chairman  
11 and ranking minority member of the Committee on Appro-  
12 priations. After general debate the bill shall be considered  
13 for amendment under the five-minute rule. Points of order  
14 against provisions in the bill for failure to comply with  
15 clause 2 of rule XXI are waived except as follows: begin-  
16 ning with “to” on page 5, line 23 through the comma on  
17 line 24; beginning with the colon on page 6, line 22  
18 through “year” on line 26; beginning with “for” on page  
19 13, line 1 through “Code” on line 6; beginning with the  
20 colon on page 13, line 17 through “expended” on line 25;  
21 and sections 120, 127, 129, 206, 530, 707, and 931.  
22 Where points of order are waived against part of a para-  
23 graph, points of order against language in another part  
24 of such paragraph may be made only against such other  
25 part and not against the entire paragraph. During consid-

1 eration of the bill for amendment, the Chairman of the  
2 Committee of the Whole may accord priority in recognition  
3 on the basis of whether the Member offering an amend-  
4 ment has caused it to be printed in the portion of the Con-  
5 gressional Record designated for that purpose in clause  
6 8 of rule XVIII. Amendments so printed shall be consid-  
7 ered as read. When the committee rises and reports the  
8 bill back to the House with a recommendation that the  
9 bill do pass, the previous question shall be considered as  
10 ordered on the bill and amendments thereto to final pas-  
11 sage without intervening motion except one motion to re-  
12 commit with or without instructions.
