A BILL

To require the Secretary of Defense to submit to Congress all documentation related to the Secretary's recommendations for the 2005 round of defense base closure and realignment.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SUBMISSION OF DOCUMENTATION RELATED**
2 **TO THE RECOMMENDATIONS OF THE SEC-**
3 **RETARY OF DEFENSE FOR THE 2005 ROUND**
4 **OF DEFENSE BASE CLOSURE AND REALIGN-**
5 **MENT.**

6 (a) IN GENERAL.—Not later than 7 days after the
7 date of the enactment of this Act, the Secretary of Defense
8 shall submit to Congress all Department of Defense docu-
9 mentation related to the 2005 round of defense base clo-
10 sure and realignment.

11 (b) SCOPE OF REQUIRED DOCUMENTATION.—The
12 documentation submitted under subsection (a) shall in-
13 clude—

14 (1) certified data collected during data calls re-
15 lated to the 2005 round of defense base closure and
16 realignment; and

17 (2) all documentation related to the application
18 by the Secretary of Defense of the military value cri-
19 teria and other criteria specified in subsections (b)
20 and (c) of section 2913 of the Defense Base Closure
21 and Realignment Act of 1990 to military installa-
22 tions recommended for closure or realignment and to
23 other military installations identified as potential re-
24 ceiving locations in connection with the closure or
25 realignment of military installations.

1 (c) TERMINATION OF ROUND FOR FAILURE TO SUB-
2 MIT DOCUMENTATION.—

3 (1) ROUND TERMINATED IN EVENT OF DISCLO-
4 SURE DELAY.—Subject to paragraph (2), sections
5 2912, 2913, and 2914 of the Defense Base Closure
6 and Realignment Act of 1990 are repealed effective
7 as of the date that is 8 days after the date of the
8 enactment of this Act.

9 (2) NO TERMINATION OF ROUND IN EVENT OF
10 TIMELY DISCLOSURE.—Paragraph (1) shall have no
11 further force or effect if the Secretary of Defense
12 submits the documentation required under sub-
13 section (a) before the deadline specified in such sub-
14 section.

15 (d) POSTPONEMENT OF 2005 ROUND OF DEFENSE
16 BASE CLOSURE AND REALIGNMENT.—For the purposes
17 of subsections (d) and (e) of section 2914 of the Defense
18 Base Closure and Realignment Act of 1990, each date
19 specified in such subsections shall be deemed to be the
20 date that is the number of days after the original date
21 that is equal to the number of days after May 16, 2005,
22 that the Department of Defense documentation related to
23 the 2005 round of defense base closure and realignment
24 is submitted by the Secretary of Defense under subsection
25 (a).

1 (e) DEFINITIONS.—In this Act:

2 (1) The term “Defense Base Closure and Re-
3 alignment Act of 1990” means the Defense Base
4 Closure and Realignment Act of 1990 (part A of
5 title XXIX of Public Law 101–510; 10 U.S.C. note).

6 (2) The term “Department of Defense docu-
7 mentation related to the 2005 round of defense base
8 closure and realignment” means all writings, com-
9 munications, and other documentation relevant to
10 the analysis and consideration of, and recommenda-
11 tions related to, military installations for purposes of
12 the 2005 round of defense base closure and realign-
13 ment that are in the care, custody, or control of the
14 Department of Defense, including all information set
15 down by handwriting, typewriting, printing,
16 photocopying, e-mail, or other form of data compila-
17 tion.
