## A BILL

To amend title 38, United States Code, to require an annual plan on outreach activities of the Department of Veterans Affairs.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Veterans Benefits Out-  
5 reach Act of 2005”.

6 **SEC. 2. ANNUAL PLAN ON OUTREACH ACTIVITIES.**

7 (a) ANNUAL PLAN REQUIRED.—Subchapter II of  
8 chapter 5 of title 38, United States Code, is amended by  
9 inserting after section 523 the following new section:

1 **“§ 523A. Annual plan on outreach activities**

2       “(a) ANNUAL PLAN REQUIRED.—The Secretary shall  
3 prepare each year a plan for the outreach activities of the  
4 Department for the following year.

5       “(b) ELEMENTS.—Each annual plan under sub-  
6 section (a) shall include the following:

7           “(1) Plans for efforts to identify veterans who  
8 are not enrolled or registered with the Department  
9 for benefits or services under the programs adminis-  
10 tered by the Secretary.

11           “(2) Plans for informing veterans and their de-  
12 pendents of modifications of the benefits and serv-  
13 ices under the programs administered by the Sec-  
14 retary, including eligibility for medical and nursing  
15 care and services.

16       “(c) COORDINATION IN DEVELOPMENT.—In devel-  
17 oping an annual plan under subsection (a), the Secretary  
18 shall consult with the following:

19           “(1) Directors or other appropriate officials of  
20 organizations recognized by the Secretary under sec-  
21 tion 5902 of this title.

22           “(2) Directors or other appropriate officials of  
23 State and local education and training programs.

24           “(3) Representatives of non-governmental orga-  
25 nizations that carry out veterans outreach programs.

1           “(4) Representatives of State and local veterans  
2           employment organizations.

3           “(5) Businesses and professional organizations.

4           “(6) Other individuals and organizations that  
5           assist veterans in adjusting to civilian life.

6           “(d) INCORPORATION OF ASSESSMENT OF PREVIOUS  
7           ANNUAL PLANS.—In developing an annual plan under  
8           subsection (a), the Secretary shall take into account the  
9           lessons learned from the implementation of previous an-  
10          nual plans under such subsection.

11          “(e) INCORPORATION OF RECOMMENDATIONS TO IM-  
12          PROVE OUTREACH AND AWARENESS.—In developing an  
13          annual plan under subsection (a), the Secretary shall in-  
14          corporate the recommendations for the improvement of  
15          veterans outreach and awareness activities included in the  
16          report submitted to Congress by the Secretary pursuant  
17          to section 805 of the Veterans Benefits Improvement Act  
18          of 2004 (Public Law 108–454).”.

19          (b) CLERICAL AMENDMENT.—The table of sections  
20          at the beginning of such chapter is amended by inserting  
21          after the item relating to section 523 the following new  
22          item:

“523A. Annual plan on outreach activities.”.
