## A BILL

To provide special rules for disaster relief employment under the Workforce Investment Act of 1998 for individuals displaced by Hurricane Katrina.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Hurricane Katrina
- 5 Employment and Training Assistance Act".

#### 1 SEC. 2. SPECIAL RULES FOR NATIONAL EMERGENCY

- 2 GRANTS RELATED TO HURRICANE KATRINA.
- 3 (a) Use of Grants for Projects Outside Dis-
- 4 ASTER AREA.—Funds provided to States that submit ap-
- 5 plications for assistance described in section 173(a)(2) of
- 6 the Workforce Investment Act of 1998 (29 U.S.C.
- 7 2918(a)(2)) to address the effects of Hurricane Katrina
- 8 may be used to provide disaster relief employment and
- 9 other assistance under section 173(d)(1) of such Act (29
- 10 U.S.C. 2918(d)(1)) on projects that provide assistance in
- 11 areas outside of the disaster area (as such term is defined
- 12 in section 173(a)(2) of such Act).
- 13 (b) Expanded Eligibility for Disaster Relief
- 14 Employment.—Funds provided to States that submit ap-
- 15 plications for assistance described in section 173(a)(2) of
- 16 the Workforce Investment Act of 1998 to address the ef-
- 17 fects of Hurricane Katrina may be used to provide disaster
- 18 relief employment and other assistance under section
- 19 173(d)(1) of such Act, or public sector employment au-
- 20 thorized under subsection (c) of this Act, to individuals
- 21 who were unemployed at the time of the emergency or
- 22 major disaster involved and to individuals who are without
- 23 employment history, in addition to individuals described
- 24 in section 173(d)(2) of the Workforce Investment Act of
- 25 1998 (29 U.S.C. 2918(d)(2)).

- 1 (c) Authorization for General Public Sector
- 2 EMPLOYMENT.—Funds provided to States that submit ap-
- 3 plications for assistance described in section 173(a)(2) of
- 4 the Workforce Investment Act of 1998 to address the ef-
- 5 fects of Hurricane Katrina may be used to provide to eligi-
- 6 ble individuals temporary employment by public sector en-
- 7 tities for a period not to exceed 6 months in addition to
- 8 disaster relief employment described in section 173(d)(1)
- 9 of such Act.
- 10 (d) Extension of the Duration of Disaster
- 11 Relief Employment.—The Secretary of Labor may ex-
- 12 tend the 6-month maximum duration of employment
- 13 under this Act and under section 173(d) of the Workforce
- 14 Investment Act of 1998 (29 U.S.C. 2918(d)) for not more
- 15 than an additional 6 months due to extraordinary cir-
- 16 cumstances.
- 17 (e) Priority for Disaster Relief Employment
- 18 Funds.—In awarding national emergency grants to
- 19 States under section 173(a)(2) of the Workforce Invest-
- 20 ment Act of 1998 (29 U.S.C. 2918(a)(2)) to address the
- 21 effects of Hurricane Katrina by providing disaster relief
- 22 employment, the Secretary of Labor shall—
- 23 (1) first, give priority to States in which areas
- that have suffered major disasters (as defined in sec-
- 25 tion 102 of the Robert T. Stafford Disaster Relief

- 1 and Emergency Assistance Act (42 U.S.C. 5122))
- 2 are located; and
- 3 (2) second, give priority to the remaining States
- 4 that have been most heavily impacted by the demand
- 5 for services by workers affected by Hurricane
- 6 Katrina.
- 7 (f) Documentation.—In providing disaster relief
- 8 employment under section 173(a)(2) of the Workforce In-
- 9 vestment Act of 1998 (29 U.S.C. 2918(a)(2)), an entity
- 10 shall not deny such employment to a worker affected by
- 11 Hurricane Katrina because of the worker's inability, due
- 12 to the effects of Hurricane Katrina, to provide at the time
- 13 of application appropriate documentation of eligibility
- 14 under section 173(d)(2) of such Act (29 U.S.C.
- 15 2918(d)(2)).
- 16 (g) Eligibility for Needs-Related Pay-
- 17 Ments.—Funds provided to States that submit applica-
- 18 tions for asisstance described in section 173(a)(2) of the
- 19 Workforce Investment Act of 1998 (29 U.S.C. 2918(a)(2))
- 20 to address the effects of Hurricane Katrina may be used
- 21 to provide needs-related payments (described in section
- 22 134(e)(3) of such Act (29 U.S.C. 2864(e)(3))) to individ-
- 23 uals described in subsection (b) who do not qualify for (or
- 24 have ceased to qualify for) unemployment compensation,
- 25 and who are not employed on a project described under

- 1 section 173(d) of such Act, for the purpose of enabling
- 2 such individuals to participate in activities described in
- 3 paragraphs (2), (3), or (4) of section 134(d) of such Act.
- 4 (h) Use of Available Funds.—With the approval
- 5 of the Secretary of Labor, any State may use funds that
- 6 remain available for expenditure under any grants award-
- 7 ed to the State under section 173 of the Workforce Invest-
- 8 ment Act of 1998 (29 U.S.C. 2918) or under this section,
- 9 to provide any assistance authorized under such section
- 10 173 or this section, or personal protective equipment not
- 11 otherwise available through public funds or private con-
- 12 tributions, to assist workers affected by Hurricane
- 13 Katrina, including workers who have relocated from areas
- 14 for which an emergency or major disaster (as defined in
- 15 section 102 of the Robert T. Stafford Disaster Relief and
- 16 Emergency Assistance Act (42 U.S.C. 5122)) was de-
- 17 clared, due to the effects of Hurricane Katrina.
- (i) Expanded Eligibility for Employment and
- 19 Training Activities.—
- 20 (1) In General.—In awarding national emer-
- gency grants under section 173(a)(1) of the Work-
- force Investment Act of 1998 (29 U.S.C.
- 23 2918(a)(1)), the Secretary may award such a grant
- to an entity to provide employment and training as-
- sistance available under section 173(a)(1) of such

Act to workers affected by Hurricane Katrina, in-

- cluding workers who have relocated from areas for which an emergency or major disaster (as defined in
- 4 section 102 of the Robert T. Stafford Disaster Relief 5 and Emergency Assistance Act (42 U.S.C. 5122))
- 6 was declared, due to the effects of Hurricane
- 7 Katrina.

- 8 (2) ELIGIBLE ENTITY.—In this subsection, the
- 9 term "entity" means a State, a local board (as de-
- fined in section 101 of the Workforce Investment
- 11 Act of 1998 (29 U.S.C. 2801)), or an entity de-
- scribed in section 166(c) of such Act (29 U.S.C.
- 13 2911(c)), that submits an application for assistance
- described in section 173(a)(1) of the Workforce In-
- vestment Act of 1998 to address the effects of Hur-
- 16 ricane Katrina.

#### 17 SEC. 3. SENSE OF CONGRESS.

- 18 (a) Mobile One-Stop Centers.—It is the sense of
- 19 Congress that States that operate mobile one-stop centers,
- 20 established as part of one-stop delivery systems authorized
- 21 under subtitle B of title I of the Workforce Investment
- 22 Act of 1998 (29 U.S.C. 2811 et seq.) should, where pos-
- 23 sible, make such centers available for use in the areas af-
- 24 fected by Hurricane Katrina, and areas where large num-

- 1 bers of workers affected by Hurricane Katrina have been
- 2 relocated.
- 3 (b) Expanded Operational Hours.—It is the
- 4 sense of Congress that one-stop operators (as such term
- 5 is defined in section 101 of the Workforce Investment Act
- 6 of 1998 (29 U.S.C. 2801) should increase access for work-
- 7 ers affected by Hurricane Katrina to the one-stop delivery
- 8 systems authorized under subtitle B of title I of such Act,
- 9 including through the implementation of expanded oper-
- 10 ational hours at one-stop centers and on-site services for
- 11 individuals in temporary housing locations.
