## A BILL

For the relief of Mr. Anton Dodaj, Mrs. Gjyljana Dodaj,  
Franc Dodaj, and Kristjan Dodaj.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. PERMANENT RESIDENT STATUS FOR MR.**

4 **ANTON DODAJ, MRS. GJYLJANA DODAJ,**

5 **FRANC DODAJ, AND KRISTJAN DODAJ.**

6 (a) IN GENERAL.—Notwithstanding subsections (a)  
7 and (b) of section 201 of the Immigration and Nationality  
8 Act, Mr. Anton Dodaj, Mrs. Gjyljana Dodaj, Franc Dodaj,  
9 and Kristjan Dodaj shall be eligible for issuance of immi-  
10 grant visas or for adjustment of status to that of aliens

1 lawfully admitted for permanent residence upon filing an  
2 application for issuance of immigrant visas under section  
3 204 of that Act or for adjustment of status to lawful per-  
4 manent resident.

5 (b) ADJUSTMENT OF STATUS.—If Mr. Anton Dodaj,  
6 Mrs. Gjyljana Dodaj, Franc Dodaj, and Kristjan Dodaj  
7 enter the United States before the filing deadline specified  
8 in subsection (c), Mr. Anton Dodaj, Mrs. Gjyljana Dodaj,  
9 Franc Dodaj, and Kristjan Dodaj shall be considered to  
10 have entered and remained lawfully and shall be eligible  
11 for adjustment of status under section 245 of the Immi-  
12 gration and Nationality Act as of the date of enactment  
13 of this Act.

14 (c) DEADLINE FOR APPLICATION AND PAYMENT OF  
15 FEES.—Subsections (a) and (b) shall apply only if the ap-  
16 plication for issuance of immigrant visas or the application  
17 for adjustment of status are filed with appropriate fees  
18 within 2 years after the date of enactment of this Act.

19 (d) REDUCTION OF IMMIGRANT VISA NUMBERS.—  
20 Upon the granting of immigrant visas or permanent resi-  
21 dence to Mr. Anton Dodaj, Mrs. Gjyljana Dodaj, Franc  
22 Dodaj, and Kristjan Dodaj, the Secretary of State shall  
23 instruct the proper officer to reduce by 4, during the cur-  
24 rent or next following fiscal year, the total number of im-  
25 migrant visas that are made available to natives of the

1 country of the aliens' birth under section 203(a) of the  
2 Immigration and Nationality Act or, if applicable, the  
3 total number of immigrant visas that are made available  
4 to natives of the country of the aliens' birth under section  
5 202(e) of that Act.
