A BILL

- To direct the Secretary of Transportation to issue regulations to reduce the incidence of child injury and death occurring inside or outside of passenger motor vehicles, and for other purposes.
 - 1 Be it enacted by the Senate and House of Representa-
 - 2 tives of the United States of America in Congress assembled,
 - 3 SECTION 1. SHORT TITLE.
 - 4 This Act may be cited as the "Cameron Gulbransen
 - 5 Kids and Cars Safety Act of 2005".
 - 6 SEC. 2. RULEMAKING REGARDING CHILD SAFETY.
 - 7 (a) Power Window Safety.—Not later than 18
 - 8 months after the date of enactment of this Act, the Sec-

- 1 retary of Transportation (referred to in this Act as the
- 2 "Secretary") shall issue regulations, applicable to all pas-
- 3 senger motor vehicles, to ensure that power windows and
- 4 panels automatically reverse direction when they detect an
- 5 obstruction to prevent children from being trapped, in-
- 6 jured, or killed.
- 7 (b) Rearward Visibility.—Not later than 18
- 8 months after the date of enactment of this Act, the Sec-
- 9 retary shall issue regulations, applicable to all passenger
- 10 motor vehicles, requiring a rearward visibility performance
- 11 standard that will provide drivers with a means for detect-
- 12 ing the presence of a person or object behind the vehicle
- 13 in order to prevent backing incidents involving death and
- 14 injury especially to small children and disabled persons.
- 15 (c) Preventing Vehicles From Rolling Away.—
- 16 Not later than 18 months after the date of enactment of
- 17 this Act, the Secretary shall issue regulations, applicable
- 18 to all passenger motor vehicles, requiring the vehicle serv-
- 19 ice brake to be engaged in all key positions and while the
- 20 key is out of the ignition, before starting the engine or
- 21 engaging the transmission in order to prevent accidents
- 22 resulting from vehicles accidentally or unintentionally roll-
- 23 ing away.
- 24 (d) Phase in Period.—The regulations issued pur-
- 25 suant to subsections (a) through (c) shall require—

1	(1) a phase-in period, as determined by the Sec-
2	retary, for compliance with the regulations, which
3	shall commence not later than 6 months after the
4	date on which final regulations are issued; and
5	(2) all new passenger motor vehicles manufac-
6	tured after the date that is 3 years after the
7	issuance of final regulations to be fully compliant
8	with such regulations.
9	(e) Database on Injuries and Deaths in Non-
10	TRAFFIC, NONCRASH EVENTS.—
11	(1) In general.—Not later than 18 months
12	after the date of enactment of this Act, the Sec-
13	retary shall establish and maintain a database of in-
14	juries and deaths in nontraffic, noncrash events in-
15	volving passenger motor vehicles.
16	(2) Contents.—The database shall include in-
17	formation regarding—
18	(A) the number, types, and proximate
19	causes of injuries and deaths resulting from the
20	events described in paragraph (1);
21	(B) the make, model, and model year of
22	passenger motor vehicles involved in such
23	events; and
24	(C) other variables that the Secretary de-
25	termines will enhance the value of the database.

1	(3) AVAILABILITY.—The Secretary shall make
2	the information contained in the database available
3	to the public.
4	(f) Defined Term.—In this section, the term "pas-
5	senger motor vehicle" has the meaning given the term in
6	section 32304(a) of title 49, United States Code.
7	SEC. 3. CHILD SAFETY INFORMATION PROGRAM.
8	(a) In General.—Not later than 18 months after
9	the date of enactment of this Act, the Secretary shall—
10	(1) supplement a consumer information pro-
11	gram relating to child safety; or
12	(2) create a new program with information
13	about hazards to children in nontraffic, noncrash in-
14	cident situations.
15	(b) Program Requirements.—In executing the
16	program under subsection (a), the Secretary shall—
17	(1) utilize information collected pursuant to sec-
18	tion 2(e) regarding nontraffic, noncrash injuries,
19	and other relevant data from private organizations,
20	to establish priorities for the program;
21	(2) address ways in which parents can mitigate
22	dangers to small children arising from back over in-
23	cidents, hyperthermia in closed vehicles, accidental
24	actuation of power windows, and similar dangers;
25	and

1 (3) make information related to the program 2 available to the public through the Internet and 3 other means.
