A BILL

- To amend the Homeland Security Act of 2002 (6 U.S.C. 101 et seq.) to ensure that the Department of Homeland Security is led by qualified, experienced personnel.
 - 1 Be it enacted by the Senate and House of Representa-
 - 2 tives of the United States of America in Congress assembled,
 - 3 SECTION 1. SHORT TITLE.
 - 4 This Act may be cited as the "Department of Home-
 - 5 land Security Qualified Leaders Act of 2005".
 - 6 SEC. 2. FINDINGS.
 - 7 Congress finds that—
 - 8 (1) the Department of Homeland Security, a
 - 9 large organization comprised of 180,000 employees

1	and 22 legacy agencies, has a complex mission of se-
2	curing the homeland from man-made and natural
3	disasters;
4	(2) the Department and the agencies within re-
5	quire strong leadership from proven managers with
6	significant experience in their respective fields; and
7	(3) the majority of positions requiring Senate
8	confirmation at the Department do not have min-
9	imum qualifications.
10	SEC. 3. QUALIFICATIONS OF CERTAIN SENIOR OFFICERS.

3	"(2) Additional qualifications.—In addi-
4	tion to any other qualification applicable to a posi-
5	tion described under paragraph (1), any individua

7	"(A) significant executive leadership and
8	management experience in the public or private
9	sector;
10	"(B) at least 5 years of significant experi-
11	ence in a field relevant to the position for which
12	the individual is nominated; and
13	"(C) a demonstrated ability to manage a
14	substantial staff and budget.
15	"(c) Exceptions.—This section shall not apply to
16	the position of—
17	"(1) the Secretary;
18	"(2) the Deputy Secretary of Homeland Secu-
19	rity; or
20	"(3) the Commandant of the Coast Guard.
