## A BILL

To amend part B of the Individuals with Disabilities Education Act to provide full Federal funding of such part.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “IDEA Full Funding  
5       Act”.

1 **SEC. 2. AMENDMENTS TO IDEA.**

2 Section 611(i) of the Individuals with Disabilities  
3 Education Act (20 U.S.C. 1411(i)) is amended to read  
4 as follows:

5 “(i) FUNDING.—For the purpose of carrying out this  
6 part, other than section 619, there are authorized to be  
7 appropriated—

8 “(1) \$16,938,917,714 for fiscal year 2007, and  
9 there are hereby appropriated \$6,355,957,174 for  
10 fiscal year 2007, which shall become available for  
11 obligation on July 1, 2007, and shall remain avail-  
12 able through September 30, 2008;

13 “(2) \$19,229,188,286 for fiscal year 2008, and  
14 there are hereby appropriated \$8,646,227,746 for  
15 fiscal year 2008, which shall become available for  
16 obligation on July 1, 2008, and shall remain avail-  
17 able through September 30, 2009;

18 “(3) \$21,519,458,857 for fiscal year 2009, and  
19 there are hereby appropriated \$10,936,498,317 for  
20 fiscal year 2009, which shall become available for  
21 obligation on July 1, 2009, and shall remain avail-  
22 able through September 30, 2010;

23 “(4) \$23,809,729,429 for fiscal year 2010, and  
24 there are hereby appropriated \$13,226,768,889 for  
25 fiscal year 2010, which shall become available for

1 obligation on July 1, 2010, and shall remain avail-  
2 able through September 30, 2011;

3 “(5) \$26,100,000,000 for fiscal year 2011, and  
4 there are hereby appropriated \$15,517,039,460 for  
5 fiscal year 2011, which shall become available for  
6 obligation on July 1, 2011, and shall remain avail-  
7 able through September 30, 2012; and

8 “(6) an amount equal to the sum of the max-  
9 imum amounts of the grants all States may receive  
10 under subsection (a)(2)(B) for fiscal year 2012 and  
11 each succeeding fiscal year, and, there are hereby  
12 appropriated for each such year an amount equal to  
13 the sum of the maximum amounts of the grants all  
14 States may receive under subsection (a)(2)(B) for  
15 the fiscal year for which the determination is made  
16 minus \$10,582,960,540, which shall become avail-  
17 able for obligation on July 1 of the fiscal year for  
18 which the determination is made and shall remain  
19 available through September 30 of the succeeding  
20 year.”.
