Mr. KENNEDY (for himself, Mr. CORZINE, and Mr. LAUTENBERG) introduced the following bill; which was read twice and referred to the Committee on Health, Education, Labor, and Pensions

A BILL

To extend the period for COBRA coverage for victims of the terrorist attacks of September 11, 2001.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Continuing Care for
5 Recovering Families Act”.

6 **SEC. 2. EXTENSION OF COBRA COVERAGE PERIOD FOR**
7 **CERTAIN INDIVIDUALS.**

8 (a) ERISA AMENDMENT.—Section 605 of the Em-
9 ployee Retirement Income Security Act of 1974 (29

1 U.S.C. 1165) is amended by adding at the end the fol-
2 lowing:

3 “(c) TEMPORARY EXTENSION OF COBRA ELECTION
4 AND COVERAGE PERIOD FOR VICTIMS OF TERRORIST AT-
5 TACKS.—

6 “(1) IN GENERAL.—In the case of an eligible
7 individual and notwithstanding subsection (a), such
8 individual may elect continuation coverage under
9 this part during the 120-day period that begins on
10 the later of—

11 “(A) the date of enactment of the Con-
12 tinuing Care for Recovering Families Act; or

13 “(B) the date on which the individual ex-
14periences the terrorism-related loss of coverage.

15 “(2) COMMENCEMENT OF COVERAGE; NO
16 REACH-BACK.—Any continuation coverage elected by
17 an eligible individual under paragraph (1) shall com-
18mence at the beginning of the 120-day election pe-
19riod described in such paragraph and shall not in-
20clude any period prior to such 120-day election pe-
21riod. In no event shall the maximum period required
22under section 602(2)(A) be less than the period dur-
23ing which the individual is an eligible individual.

1 “(3) PREEXISTING CONDITIONS.—With respect
2 to an individual who elects continuation coverage
3 pursuant to paragraph (1), the period—

4 “(A) beginning on the date of the ter-
5 rorism-related loss of coverage, and

6 “(B) ending on the first day of the 120-
7 day election period described in paragraph (1),
8 shall be disregarded for purposes of deter-
9 mining the 63-day periods referred to in section
10 701(c)(2), section 2701(c)(2) of the Public
11 Health Service Act, and section 9801(c)(2) of
12 the Internal Revenue Code of 1986.

13 “(4) DEFINITIONS.—For purposes of this sub-
14 section:

15 “(A) ELIGIBLE INDIVIDUAL.—The term
16 ‘eligible individual’ means an individual who—

17 “(i)(I) is the child of an individual de-
18 scribed in section 405(c)(2) of the Sep-
19 tember 11th Victim Compensation Fund of
20 2001; or

21 “(II) was the spouse of an individual
22 described in section 405(c)(2) of the Sep-
23 tember 11th Victim Compensation Fund of
24 2001, on September 11, 2001;

1 “(ii) has experienced a terrorism-re-
2 lated loss of coverage; and

3 “(iii) is not otherwise entitled to bene-
4 fits, or enrolled, under part A of title
5 XVIII of the Social Security Act or en-
6 rolled under part B of such title.

7 “(B) TERRORISM-RELATED LOSS OF COV-
8 ERAGE.—The term ‘terrorism-related loss of
9 coverage’ means, with respect to an eligible in-
10 dividual, the loss of health benefits coverage as-
11 sociated with the death, injury, or loss of em-
12 ployment of an individual described in section
13 405(c)(2) of the September 11th Victim Com-
14 pensation Fund of 2001.”.

15 (b) PHSA AMENDMENT.—Section 2205 of the Public
16 Health Service Act (42 U.S.C. 300bb–5) is amended by
17 adding at the end the following:

18 “(c) TEMPORARY EXTENSION OF COBRA ELECTION
19 AND COVERAGE PERIOD FOR VICTIMS OF TERRORIST AT-
20 TACKS.—

21 “(1) IN GENERAL.—In the case of an eligible
22 individual and notwithstanding subsection (a), such
23 individual may elect continuation coverage under
24 this title during the 120-day period that begins on
25 the later of—

1 “(A) the date of enactment of the Con-
2 tinuing Care for Recovering Families Act; or

3 “(B) the date on which the individual ex-
4 periences the terrorism-related loss of coverage.

5 “(2) COMMENCEMENT OF COVERAGE; NO
6 REACH-BACK.—Any continuation coverage elected by
7 an eligible individual under paragraph (1) shall com-
8 mence at the beginning of the 120-day election pe-
9 riod described in such paragraph and shall not in-
10 clude any period prior to such 120-day election pe-
11 riod. In no event shall the maximum period required
12 under section 2202(2)(A) be less than the period
13 during which the individual is an eligible individual.

14 “(3) PREEXISTING CONDITIONS.—With respect
15 to an individual who elects continuation coverage
16 pursuant to paragraph (1), the period—

17 “(A) beginning on the date of the ter-
18 rorism-related loss of coverage, and

19 “(B) ending on the first day of the 120-
20 day election period described in paragraph (1),
21 shall be disregarded for purposes of deter-
22 mining the 63-day periods referred to in section
23 2701(c)(2), section 701(c)(2) of the Employee
24 Retirement Income Security Act of 1974, and

1 section 9801(c)(2) of the Internal Revenue
2 Code of 1986.

3 “(4) DEFINITIONS.—For purposes of this sub-
4 section:

5 “(A) ELIGIBLE INDIVIDUAL.—The term
6 ‘eligible individual’ means an individual who—

7 “(i)(I) is the child of an individual de-
8 scribed in section 405(c)(2) of the Sep-
9 tember 11th Victim Compensation Fund of
10 2001; or

11 “(II) was the spouse of an individual
12 described in section 405(c)(2) of the Sep-
13 tember 11th Victim Compensation Fund of
14 2001, on September 11, 2001;

15 “(ii) has experienced a terrorism-re-
16 lated loss of coverage; and

17 “(iii) is not otherwise entitled to bene-
18 fits, or enrolled, under part A of title
19 XVIII of the Social Security Act or en-
20 rolled under part B of such title.

21 “(B) TERRORISM-RELATED LOSS OF COV-
22 ERAGE.—The term ‘terrorism-related loss of
23 coverage’ means, with respect to an eligible in-
24 dividual, the loss of health benefits coverage as-
25 sociated with the death, injury, or loss of em-

1 ployment of an individual described in section
 2 405(c)(2) of the September 11th Victim Com-
 3 pensation Fund of 2001.”.

4 (c) IRC AMENDMENTS.—Paragraph (5) of section
 5 4980B(f) of the Internal Revenue Code of 1986 (relating
 6 to election) is amended by adding at the end the following:

7 “(D) TEMPORARY EXTENSION OF COBRA
 8 ELECTION AND COVERAGE PERIOD FOR VICTIMS
 9 OF TERRORIST ATTACKS.—

10 “(i) IN GENERAL.—In the case of an
 11 eligible individual and notwithstanding
 12 paragraph (1), such individual may elect
 13 continuation coverage under this title dur-
 14 ing the 120-day period that begins on the
 15 later of—

16 “(I) the date of enactment of the
 17 Continuing Care for Recovering Fami-
 18 lies Act; or

19 “(II) the date on which the indi-
 20 vidual experiences the terrorism-re-
 21 lated loss of coverage.

22 “(ii) COMMENCEMENT OF COVERAGE;
 23 NO REACH-BACK.—Any continuation cov-
 24 erage elected by an eligible individual
 25 under clause (i) shall commence at the be-

1 ginning of the 120-day election period de-
2 scribed in such clause and shall not include
3 any period prior to such 120-day election
4 period. In no event shall the maximum pe-
5 riod required under paragraph (2)(B)(i) be
6 less than the period during which the indi-
7 vidual is an eligible individual.

8 “(iii) PREEXISTING CONDITIONS.—
9 With respect to an individual who elects
10 continuation coverage pursuant to clause
11 (i), the period—

12 “(I) beginning on the date of the
13 terrorism-related loss of coverage, and

14 “(II) ending on the first day of
15 the 120-day election period described
16 in clause (i), shall be disregarded for
17 purposes of determining the 63-day
18 periods referred to in section
19 9801(c)(2), section 701(c)(2) of the
20 Employee Retirement Income Security
21 Act of 1974, and section 2701(c)(2)
22 of the Public Health Service Act.

23 “(iv) DEFINITIONS.—For purposes of
24 this subparagraph:

1 “(I) ELIGIBLE INDIVIDUAL.—

2 The term ‘eligible individual’ means
3 an individual who—

4 “(aa)(AA) is the child of an
5 individual described in section
6 405(c)(2) of the September 11th
7 Victim Compensation Fund of
8 2001; or

9 “(BB) was the spouse of an
10 individual described in section
11 405(c)(2) of the September 11th
12 Victim Compensation Fund of
13 2001, on September 11, 2001;

14 “(bb) has experienced a ter-
15 rorism-related loss of coverage;
16 and

17 “(cc) is not otherwise enti-
18 tled to benefits, or enrolled,
19 under part A of title XVIII of
20 the Social Security Act or en-
21 rolled under part B of such title.

22 “(II) TERRORISM-RELATED LOSS
23 OF COVERAGE.—The term ‘terrorism-
24 related loss of coverage’ means, with
25 respect to an eligible individual, the

1 loss of health benefits coverage associ-
2 ated with the death, injury, or loss of
3 employment of an individual described
4 in section 405(c)(2) of the September
5 11th Victim Compensation Fund of
6 2001.”.
