## A BILL

To clarify the applicability of deadlines relating to construction of hydroelectric projects to certain hydroelectric projects located or proposed to be located on the Upper Hudson River in the State of New York.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. CONSTRUCTION OF HYDROELECTRIC
- 4 PROJECTS.
- 5 (a) Definitions.—In this section:
- 6 (1) Hudson river pcb site.—The term
- 7 "Hudson River PCB site" means the site identified
- 8 as No. NYD980763841 and located along the Hud-

- son River in the State of New York that was added to the National Priorities List on September 21, 1984.
- 4 (2) Hydroelectric project.—The term "hy-5 droelectric project" means a hydroelectric project 6 that is—
- 7 (A) licensed by the Federal Energy Regu-8 latory Commission on or after September 21, 9 1984; and
- 10 (B) located or proposed to be located on 11 the Upper Hudson River, between Hudson 12 Falls and Federal Dam at Troy, New York, in 13 the area of the Hudson River PCB site that has 14 been targeted for dredging of approximately 15 2,650,000 cubic yards of PCB-contaminated 16 sediment.
- 17 (3) NATIONAL PRIORITIES LIST.—The term
  18 "National Priorities List" means the list of sites de19 veloped by the President in accordance with section
  20 105(a)(8)(B) of the Comprehensive Environmental
  21 Response, Compensation, and Liability Act of 1980
  22 (42 U.S.C. 9605(a)(8)(B)).
- 23 (b) APPLICABILITY OF CONSTRUCTION DEAD-24 LINES.—The time periods specified in section 13 of the 25 Federal Power Act (16 U.S.C. 806) for commencement

- 1 and completion of construction of a hydroelectric project,
- 2 and any corresponding time period contained in a license
- 3 for the hydroelectric project, shall not begin to run until
- 4 the date on which the Hudson River PCB site, or the por-
- 5 tion of the Hudson River PCB site on which the hydro-
- 6 electric project is located or proposed to be located, has
- 7 been—
- 8 (1) removed from the National Priorities List;
- 9 or
- 10 (2) otherwise approved for use for construction
- of the hydroelectric project by the Administrator of
- the Environmental Protection Agency.
- 13 (c) Orders of FERC.—An order of the Federal En-
- 14 ergy Regulatory Commission that is issued before the date
- 15 of enactment of this Act that addresses a deadline that,
- 16 in accordance with subsection (b), has not yet begun to
- 17 run, shall be considered to be void and of no legal effect
- 18 with respect to any failure by a licensee to meet the dead-
- 19 line.
