Mr. Obama introduced the following bill; which was read twice and referred to the Committee on Veterans' Affairs

A BILL

To amend title 38, United States Code, to establish a Hospital Quality Report Card Initiative to report on health care quality in Veterans Affairs hospitals.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "VA Hospital Quality
- 5 Report Card Act of 2006".
- 6 SEC. 2. PURPOSE.
- 7 The purpose of this Act is to establish the Hospital
- 8 Quality Report Card Initiative under title 38, United
- 9 States Code, to ensure that quality measures data for hos-

- 1 pitals administered by the Secretary of Veterans Affairs
- 2 are readily available and accessible in order to—
- 3 (1) inform patients and consumers about health
- 4 care quality in such hospitals;
- 5 (2) assist Veterans Affairs health care providers
- 6 in identifying opportunities for quality improvement
- 7 and cost containment; and
- 8 (3) enhance the understanding of policy makers
- 9 and public officials of health care issues, raise public
- awareness of hospital quality issues, and to help con-
- stituents of such policy makers and officials identify
- 12 quality health care options.

13 SEC. 3. VA HOSPITAL QUALITY REPORT CARD INITIATIVE.

- 14 (a) IN GENERAL.—Subchapter III of chapter 17 of
- 15 title 38, United States Code, is amended by adding at the
- 16 end the following new section:

17 "§ 1730A. Hospital Quality Report Card Initiative

- 18 "(a) Not later than 18 months after the date of the
- 19 enactment of the VA Hospital Quality Report Card Act
- 20 of 2006, the Secretary shall establish and implement a
- 21 Hospital Quality Report Card Initiative (in this section re-
- 22 ferred to as the 'Initiative') to report on health care qual-
- 23 ity in VA hospitals.
- 24 "(b) For purposes of this section, the term 'VA hos-
- 25 pital' means a hospital administered by the Secretary.

1 "(vi) the availability of emergency rooms, inten-2 sive care units, maternity care, and specialty serv-3 ices; "(vii) the quality of care in various hospital set-4 5 tings, including inpatient, outpatient, emergency, 6 maternity, and intensive care unit settings; "(viii) ongoing patient safety initiatives; and 7 "(ix) other measures determined appropriate by 8 9 the Secretary. "(C)(i) In reporting data as provided for under sub-10 11 paragraph (A), the Secretary may risk adjust quality 12 measures to account for differences relating to— 13 "(I) the characteristics of the reporting VA hos-14 pital, such as licensed bed size, geography, and 15 teaching hospital status; and "(II) patient characteristics, such as health sta-16 17 tus, severity of illness, and socioeconomic status. 18 "(ii) If the Secretary reports data under subpara-19 graph (A) using risk-adjusted quality measures, the Sec-20 establish procedures retary shall for making 21 unadjusted data available to the public in a manner deter-22 mined appropriate by the Secretary. 23 "(D) Under the Initiative, the Secretary may verify data reported under this paragraph to ensure accuracy and validity. 25

- 1 "(E) The Secretary shall disclose the entire method-
- 2 ology for the reporting of data under this paragraph to
- 3 all relevant organizations and VA hospitals that are the
- 4 subject of any such information that is to be made avail-
- 5 able to the public prior to the public disclosure of such
- 6 information.
- 7 "(F)(i) The Secretary shall submit each report to the
- 8 appropriate committees of Congress.
- 9 "(ii) The Secretary shall ensure that reports are
- 10 made available under this section in an electronic format,
- 11 in an understandable manner with respect to various pop-
- 12 ulations (including those with low functional health lit-
- 13 eracy), and in a manner that allows health care quality
- 14 comparisons to be made with local hospitals or regional
- 15 hospitals, as appropriate.
- 16 "(iii) The Secretary shall establish procedures for
- 17 making report findings available to the public, upon re-
- 18 quest, in a non-electronic format, such as through a toll-
- 19 free telephone number.
- 20 "(G) The analytic methodologies and limitations on
- 21 data sources utilized by the Secretary to develop and dis-
- 22 seminate the comparative data under this section shall be
- 23 identified and acknowledged as part of the dissemination
- 24 of such data, and include the appropriate and inappro-
- 25 priate uses of such data.

- 1 "(H) On at least an annual basis, the Secretary shall
- 2 compare quality measures data submitted by each VA hos-
- 3 pital with data submitted in the prior year or years by
- 4 the same hospital in order to identify and report actions
- 5 that would lead to false or artificial improvements in the
- 6 hospital's quality measurements.
- 7 "(2)(A) The Secretary shall develop and implement
- 8 effective safeguards to protect against the unauthorized
- 9 use or disclosure of VA hospital data that is reported
- 10 under this section.
- 11 "(B) The Secretary shall develop and implement ef-
- 12 fective safeguards to protect against the dissemination of
- 13 inconsistent, incomplete, invalid, inaccurate, or subjective
- 14 VA hospital data.
- 15 "(C) The Secretary shall ensure that identifiable pa-
- 16 tient data shall not be released to the public.
- 17 "(d)(1) The Secretary shall evaluate and periodically
- 18 submit a report to Congress on the effectiveness of the
- 19 Initiative, including the effectiveness of the Initiative in
- 20 meeting the purpose described in section 2 of the VA Hos-
- 21 pital Quality Report Card Act of 2006. The Secretary
- 22 shall make such reports available to the public.
- 23 "(2) The Secretary shall use the outcomes from the
- 24 evaluation conducted pursuant to paragraph (1) to in-
- 25 crease the usefulness of the Initiative.

- 1 "(e) There are authorized to be appropriated to carry
- 2 out this section such sums as may be necessary for each
- 3 of fiscal years 2007 through 2016.".
- 4 (b) CLERICAL AMENDMENT.—The table of sections
- 5 at the beginning of chapter 17, United States Code, is
- 6 amended by inserting after the item relating to section
- 7 1730 the following new item:

"1730A. Hospital Quality Report Card Initiative.".
