Ms. MIKULSKI introduced the following bill; which was read twice and referred to the Committee on Veterans' Affairs

A BILL

To amend title 38, United States Code, to increase burial benefits for veterans, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Veterans Burial Bene-
5 fits Improvement Act of 2006”.

6 **SEC. 2. INCREASE IN BURIAL AND FUNERAL BENEFITS FOR**
7 **VETERANS.**

8 (a) INCREASE IN BURIAL AND FUNERAL EXPENSES
9 AND PROVISION FOR ANNUAL COST-OF-LIVING ADJUST-
10 MENT.—

1 (1) EXPENSES GENERALLY.—Section 2302(a)
 2 of title 38, United States Code, is amended by strik-
 3 ing “\$300” and inserting “\$1,135 (as increased
 4 from time to time under section 2309 of this title)”.

5 (2) EXPENSES FOR DEATHS IN DEPARTMENT
 6 FACILITIES.—Section 2303(a)(1)(A) of such title is
 7 amended by striking “\$300” and inserting “\$1,135
 8 (as increased from time to time under section 2309
 9 of this title)”.

10 (3) EXPENSES FOR DEATHS FROM SERVICE-
 11 CONNECTED DISABILITIES.—Section 2307 of such
 12 title is amended by striking “\$2,000,” and inserting
 13 “\$3,712 (as increased from time to time under sec-
 14 tion 2309 of this title),”.

15 (b) PLOT ALLOWANCE.—Section 2303(b) of such
 16 title is amended—

17 (1) by striking “\$300” the first place it appears
 18 and inserting “\$670 (as increased from time to time
 19 under section 2309 of this title)”; and

20 (2) by striking “\$300” the second place it ap-
 21 pears and inserting “\$670 (as so increased)”.

22 (c) ANNUAL ADJUSTMENT.—

23 (1) IN GENERAL.—Chapter 23 of such title is
 24 amended by adding at the end the following new sec-
 25 tion:

1 **“§ 2309. Annual adjustment of amounts of burial ben-**
 2 **efits**

3 “With respect to any fiscal year, the Secretary shall
 4 provide a percentage increase (rounded to the nearest dol-
 5 lar) in the burial and funeral expenses under sections
 6 2302(a), 2303(a), and 2307 of this title, and in the plot
 7 allowance under section 2303(b) of this title, equal to the
 8 percentage by which—

9 “(1) the Consumer Price Index (all items,
 10 United States city average) for the 12-month period
 11 ending on the June 30 preceding the beginning of
 12 the fiscal year for which the increase is made, ex-
 13 ceeds

14 “(2) the Consumer Price Index for the 12-
 15 month period preceding the 12-month period de-
 16 scribed in paragraph (1).”.

17 (2) CLERICAL AMENDMENT.—The table of sec-
 18 tions at the beginning of such chapter is amended
 19 by adding at the end the following new item:

“2309. Annual adjustment of amounts of burial benefits.”.

20 (d) EFFECTIVE DATE.—

21 (1) IN GENERAL.—Except as provided in para-
 22 graph (2), the amendments made by this section
 23 shall apply to deaths occurring on or after the date
 24 of the enactment of this Act.

1 (2) PROHIBITION ON COST-OF-LIVING ADJUST-
2 MENT FOR FISCAL YEAR 2007.—No adjustments
3 shall be made under section 2309 of title 38, United
4 States Code, as added by subsection (c), for fiscal
5 year 2007.
