## A BILL

To amend the Omnibus Crime Control and Safe Streets Act of 1968 to clarify that Indian tribes are eligible to receive grants for confronting the use of methamphetamine, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Indian Tribes Meth-  
5 amphetamine Reduction Grants Act of 2006”.

1 **SEC. 2. INDIAN TRIBES PARTICIPATION IN METHAMPHET-**  
 2 **AMINE GRANTS.**

3 (a) IN GENERAL.—Section 2996(a) of the Omnibus  
 4 Crime Control and Safe Streets Act of 1968 is amended—

5 (1) in paragraph (1)—

6 (A) in the matter preceding subparagraph  
 7 (A), by inserting “and Indian tribes (as defined  
 8 in section 2704)” after “to assist States”; and

9 (B) in subparagraph (B), by inserting “,  
 10 Tribal,” before “and local”;

11 (2) in paragraph (2), by inserting “and Indian  
 12 tribes” after “make grants to States”; and

13 (3) in paragraph (3)(C), by inserting “, Trib-  
 14 al,” after “support State”.

15 (b) GRANT PROGRAMS FOR DRUG ENDANGERED  
 16 CHILDREN.—Section 755(a) of the USA PATRIOT Im-  
 17 provement and Reauthorization Act of 2005 (Public Law  
 18 109-177) is amended by inserting “and Indian tribes (as  
 19 defined in section 2704 of the Omnibus Crime Control and  
 20 Safe Streets Act of 1968 (42 U.S.C. 3797d))” after  
 21 “make grants to States”.

22 (c) GRANT PROGRAMS TO ADDRESS METHAMPHET-  
 23 AMINE USE BY PREGNANT AND PARENTING WOMEN OF-  
 24 FENDERS.—Section 756 of the USA PATRIOT Improve-  
 25 ment and Reauthorization Act of 2005 (Public Law 109-  
 26 177) is amended—

(1) in subsection (a)(2), by inserting “, territorial, or Tribal” after “State”;

(2) in subsection (b)—

(A) in paragraph (1)—

(i) by inserting “, territorial, or Tribal” after “State”; and

(ii) by striking “and/or” and inserting “or”;

(B) in paragraph (2)—

(i) by inserting “, territory, or Indian tribe” after “agency of the State”; and

(ii) by inserting “, territory, or Indian tribe” after “criminal laws of that State”; and

(C) by adding at the end the following:

“(3) INDIAN TRIBE.—The term ‘Indian tribe’ has the same meaning as in section 2704 of the Omnibus Crime Control and Safe Streets Act of 1968 (42 U.S.C. 3797d)).”; and

(3) in subsection (c)—

(A) in paragraph (3), by striking “Indian Tribe” and inserting “Indian tribe”; and

(B) in paragraph (4)—

(i) in the matter preceding subparagraph (A)—

1 (I) by striking “State’s services”  
2 and inserting “services of the State,  
3 territory, or Tribe”; and

4 (II) by striking “and/or” and in-  
5 serting “or”;

6 (ii) in subparagraph (A), by striking  
7 “State”;

8 (iii) in subparagraph (C), by inserting  
9 “, Indian tribes,” after “involved coun-  
10 ties”; and

11 (iv) in subparagraph (D), by inserting  
12 “, Tribal” after “Federal, State”.
