7 (2) ASSIGNABILITY OF PAYMENTS.—Section
 8 8346(a) of title 5, United States Code, is amended
 9 by striking “except under” and inserting “except to
 10 a trust meeting the requirements of subparagraph
 11 (A) or (C) of section 1917(d)(4) of the Social Secu-
 12 rity Act (42 U.S.C. 1396p(d)(4) (A) or (C)) or
 13 under”.

14 (b) FEDERAL EMPLOYEES RETIREMENT SYSTEM.—

15 (1) PAYMENTS.—Section 8466(c) of title 5,
 16 United States Code, is amended in the first sentence
 17 by inserting before the period “, or is a trustee
 18 under a trust meeting the requirements of subpara-
 19 graph (A) or (C) of section 1917(d)(4) of the Social
 20 Security Act (42 U.S.C. 1396p(d)(4) (A) or (C))”.

21 (2) ASSIGNABILITY OF PAYMENTS.—Section
 22 8470(a) of title 5, United States Code, is amended
 23 by striking “except under” and inserting “except to
 24 a trust meeting the requirements of subparagraph
 25 (A) or (C) of section 1917(d)(4) of the Social Secu-
