To establish grant programs to improve the health of border area residents and for bioterrorism preparedness in the border area, and for other purposes.

Mr. BINGAMAN (for himself, Mrs. Hutchison, Mrs. Feinstein, and Mrs. Boxer) introduced the following bill; which was read twice and referred to the Committee on Health, Education, Labor, and Pensions

## A BILL

To establish grant programs to improve the health of border area residents and for bioterrorism preparedness in the border area, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Border Health Secu-
- 5 rity Act of 2006".
- 6 SEC. 2. DEFINITIONS.
- 7 In this Act:
- 8 (1) BORDER AREA.—The term "border area"
- 9 has the meaning given the term "United States-

- 1 Mexico Border Area" in section 8 of the United
- 2 States-Mexico Border Health Commission Act (22)
- 3 U.S.C. 290n-6).
- 4 (2) Secretary.—The term "Secretary" means
- 5 the Secretary of Health and Human Services.

#### 6 SEC. 3. BORDER HEALTH GRANTS.

- 7 (a) ELIGIBLE ENTITY DEFINED.—In this section,
- 8 the term "eligible entity" means a State, public institution
- 9 of higher education, local government, tribal government,
- 10 nonprofit health organization, or community health center
- 11 receiving assistance under section 330 of the Public
- 12 Health Service Act (42 U.S.C. 254b), that is located in
- 13 the border area.
- 14 (b) AUTHORIZATION.—From funds appropriated
- 15 under subsection (f), the Secretary, acting through the
- 16 United States members of the United States-Mexico Bor-
- 17 der Health Commission, shall award grants to eligible en-
- 18 tities to address priorities and recommendations to im-
- 19 prove the health of border area residents that are estab-
- 20 lished by—
- 21 (1) the United States members of the United
- 22 States-Mexico Border Health Commission;
- 23 (2) the State border health offices; and
- 24 (3) the Secretary.

1	(c) Application.—An eligible entity that desires a
2	grant under subsection (b) shall submit an application to
3	the Secretary at such time, in such manner, and con-
4	taining such information as the Secretary may require.
5	(d) Use of Funds.—An eligible entity that receives
6	a grant under subsection (b) shall use the grant funds
7	for—
8	(1) programs relating to—
9	(A) maternal and child health;
10	(B) primary care and preventative health;
11	(C) public health and public health infra-
12	structure;
13	(D) health promotion;
14	(E) oral health;
15	(F) behavioral and mental health;
16	(G) substance abuse;
17	(H) health conditions that have a high
18	prevalence in the border area;
19	(I) medical and health services research;
20	(J) workforce training and development;
21	(K) community health workers or
22	promotoras;
23	(L) health care infrastructure problems in
24	the border area (including planning and con-
25	struction grants);

(M) health disparities in the border area;

2	(N) environmental health;
3	(O) health education; and
4	(P) outreach and enrollment services with
5	respect to Federal programs (including pro-
6	grams authorized under titles XIX and XXI of
7	the Social Security Act (42 U.S.C. 1396 and
8	1397aa)); and
9	(2) other programs determined appropriate by
10	the Secretary.
11	(e) Supplement, Not Supplant.—Amounts pro-
12	vided to an eligible entity awarded a grant under sub-
13	section (b) shall be used to supplement and not supplant
14	other funds available to the eligible entity to carry out the
15	activities described in subsection (d).
16	(f) AUTHORIZATION OF APPROPRIATIONS.—There is
17	authorized to be appropriated to carry out this section
18	such sums as may be necessary for fiscal year 2007 and
19	each succeeding fiscal year.
20	SEC. 4. BORDER BIOTERRORISM PREPAREDNESS GRANTS.
21	(a) Eligible Entity Defined.—In this section,
22	the term "eligible entity" means a State, local govern-
23	ment, tribal government, or public health entity.
24	(b) Authorization.—From funds appropriated
25	under subsection (e), the Secretary shall award grants to

1	eligible entities for bioterrorism preparedness in the bor-
2	der area.
3	(c) APPLICATION.—An eligible entity that desires a
4	grant under this section shall submit an application to the
5	Secretary at such time, in such manner, and containing
6	such information as the Secretary may require.
7	(d) Uses of Funds.—An eligible entity that receives
8	a grant under subsection (b) shall use the grant funds to,
9	in coordination with State and local bioterrorism pro-
10	grams—
11	(1) develop and implement bioterror prepared-
12	ness plans and readiness assessments and purchase
13	items necessary for such plans;
14	(2) coordinate bioterrorism and emergency pre-
15	paredness planning in the region;
16	(3) improve infrastructure, including syndrome
17	surveillance and laboratory capacity;
18	(4) create a health alert network, including risk
19	communication and information dissemination;
20	(5) educate and train clinicians, epidemiolo-
21	gists, laboratories, and emergency personnel; and
22	(6) carry out such other activities identified by
23	the Secretary, the United States-Mexico Border
24	Health Commission, State and local public health of-

fices, and border health offices.

1	(e) AUTHORIZATION OF APPROPRIATIONS.—There is
2	authorized to be appropriated to carry out this section
3	\$25,000,000 for fiscal year 2007 and such sums as may
4	be necessary for each succeeding fiscal year.
5	SEC. 5. UNITED STATES-MEXICO BORDER HEALTH COMMIS-
6	SION ACT AMENDMENTS.
7	The United States-Mexico Border Health Commis-
8	sion Act (22 U.S.C. 290n et seq.) is amended by adding
9	at the end the following:
10	"SEC. 9. AUTHORIZATION OF APPROPRIATIONS.
11	"There is authorized to be appropriated to carry out
12	this Act $$10,000,000$ for fiscal year $2007$ and such sums
13	as may be necessary for each succeeding fiscal year.".
14	SEC. 6. COORDINATION OF HEALTH SERVICES AND SUR-
15	VEILLANCE.
16	The Secretary may coordinate with the Secretary of
17	Homeland Security in establishing a health alert system
18	that—
19	(1) alerts clinicians and public health officials
20	of emerging disease clusters and syndromes along
21	the border area; and
22	(2) is alerted to signs of health threats or bio-
23	terrorism along the border area.

### 1 SEC. 7. BINATIONAL PUBLIC HEALTH INFRASTRUCTURE

- 2 AND HEALTH INSURANCE.
- 3 (a) In General.—The Secretary of Health and
- 4 Human Services shall enter into a contract with the Insti-
- 5 tute of Medicine for the conduct of a study concerning
- 6 binational public health infrastructure and health insur-
- 7 ance efforts. In conducting such study, the Institute shall
- 8 solicit input from border health experts and health insur-
- 9 ance issuers.
- 10 (b) Report.—Not later than 1 year after the date
- 11 on which the Secretary of Health and Human Services en-
- 12 ters into the contract under subsection (a), the Institute
- 13 of Medicine shall submit to the Secretary and the appro-
- 14 priate committees of Congress a report concerning the
- 15 study conducted under such contract. Such report shall
- 16 include the recommendations of the Institute on ways to
- 17 expand or improve binational public health infrastructure
- 18 and health insurance efforts.
- 19 SEC. 8. PROVISION OF RECOMMENDATIONS AND ADVICE
- TO CONGRESS.
- 21 Section 5 of the United States-Mexico Border Health
- 22 Commission Act (22 U.S.C. 290n-3) is amended by add-
- 23 ing at the end the following:
- 24 "(d) Providing Advice and Recommendations
- 25 TO CONGRESS.—A member of the Commission, or an indi-
- 26 vidual who is on the staff of the Commission, may at any

- 1 time provide advice or recommendations to Congress con-
- 2 cerning issues that are considered by the Commission.
- 3 Such advice or recommendations may be provided whether
- 4 or not a request for such is made by a member of Congress
- 5 and regardless of whether the member or individual is au-
- 6 thorized to provide such advice or recommendations by the
- 7 Commission or any other Federal official.".
