Ms. MIKULSKI (for herself, Mr. SARBANES, Mr. DURBIN, and Mr. OBAMA) introduced the following bill; which was read twice and referred to the Committee on Health, Education, Labor, and Pensions

## A BILL

To build capacity at community colleges in order to meet increased demand for community college education while maintaining the affordable tuition rates and the open-door policy that are the hallmarks of the community college system.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. COMMUNITY COLLEGE CAPACITY-BUILDING**  
4       **GRANT PROGRAM.**

5       Title III of the Higher Education Act of 1965 (20  
6       U.S.C. 1051 et seq.) is amended—

7               (1) by redesignating part F as part G; and

1 (2) by inserting after part E the following:

2 **“PART F—COMMUNITY COLLEGES**

3 **“SEC. 371. COMMUNITY COLLEGE CAPACITY-BUILDING**  
 4 **GRANT PROGRAM.**

5 “(a) PROGRAM AUTHORIZED.—

6 “(1) IN GENERAL.—From amounts appro-  
 7 priated under section 399(a)(6) for a fiscal year, the  
 8 Secretary shall award grants to eligible entities, on  
 9 a competitive basis, for the purpose of building ca-  
 10 pacity at community colleges to meet the increased  
 11 demand for community colleges while maintaining  
 12 the affordable tuition rates and the open-door policy  
 13 that are the hallmarks of the community college sys-  
 14 tem.

15 “(2) DURATION.—Grants awarded under this  
 16 section shall be for a period not to exceed 3 years.

17 “(b) DEFINITIONS.—In this section:

18 “(1) COMMUNITY COLLEGE.—The term ‘com-  
 19 munity college’ means a public institution of higher  
 20 education (as defined in section 101(a)) whose high-  
 21 est degree awarded is predominantly the associate  
 22 degree.

23 “(2) ELIGIBLE ENTITY.—The term ‘eligible en-  
 24 tity’ means a community college, or a consortium of  
 25 2 or more community colleges, that demonstrates ca-

1 capacity challenges at not less than 1 of the commu-  
2 nity colleges in the eligible entity, such as—

3 “(A) an identified workforce shortage in  
4 the community served by the community college  
5 that will be addressed by increased enrollment  
6 at the community college;

7 “(B) a wait list for a class or for a degree  
8 or a certificate program;

9 “(C) a faculty shortage;

10 “(D) a significant enrollment growth;

11 “(E) a significant projected enrollment  
12 growth;

13 “(F) an increase in the student-faculty  
14 ratio;

15 “(G) a shortage of laboratory space or  
16 equipment;

17 “(H) a shortage of computer equipment  
18 and technology;

19 “(I) out-of-date computer equipment and  
20 technology;

21 “(J) a decrease in State or county funding  
22 or a related budget shortfall; or

23 “(K) another demonstrated capacity short-  
24 fall.

1       “(c) APPLICATION.—Each eligible entity desiring a  
 2 grant under this section shall submit an application to the  
 3 Secretary at such time, in such manner, and accompanied  
 4 by such information as the Secretary may reasonably re-  
 5 quire by regulation.

6       “(d) AWARD BASIS.—In awarding grants under sub-  
 7 section (a), the Secretary shall take into consideration—

8               “(1) the relative need for assistance under this  
 9 section of the community colleges;

10              “(2) the probable impact and overall quality of  
 11 the proposed activities on the capacity problem of  
 12 the community college;

13              “(3) providing an equitable geographic distribu-  
 14 tion of grant funds under this section throughout  
 15 the United States and among urban, suburban, and  
 16 rural areas of the United States; and

17              “(4) providing an equitable distribution among  
 18 small, medium, and large community colleges.

19       “(e) USE OF FUNDS.—Grant funds provided under  
 20 subsection (a) may be used for activities that expand com-  
 21 munity college capacity, including—

22              “(1) the construction, maintenance, renovation,  
 23 and improvement of classroom, library, laboratory,  
 24 and other instructional facilities;

1           “(2) the purchase, rental, or lease of scientific  
2           or laboratory equipment for educational purposes,  
3           including instructional research purposes;

4           “(3) the development, improvement, or expansion of technology;

6           “(4) preparation and professional development  
7           of faculty;

8           “(5) recruitment, hiring, and retention of faculty;

10          “(6) curriculum development and academic instruction;

12          “(7) the purchase of library books, periodicals,  
13          and other educational materials, including telecommunications program material;

15          “(8) the joint use of facilities, such as laboratories and libraries; or

17          “(9) the development of partnerships with local  
18          businesses to increase community college capacity.

19   **“SEC. 372. APPLICABILITY.**

20          “The provisions of part G (other than section 399)  
21          shall not apply to this part.”.

22   **SEC. 2. AUTHORIZATION OF APPROPRIATIONS.**

23          Section 399(a) of the Higher Education Act of 1965  
24          (20 U.S.C. 1068h(a)) is amended by adding at the end  
25          the following:

1           “(6) PART F.—There are authorized to be ap-  
2           propriated to carry out part F, \$500,000,000 for fis-  
3           cal year 2006, and such sums as may be necessary  
4           for each of the 4 succeeding fiscal years.”.
