A BILL

- To amend the Public Health Service Act to establish a scholarship and loan repayment program for public health preparedness workforce development to eliminate critical public health preparedness workforce shortages in Federal, State, local, and tribal public health agencies.
 - 1 Be it enacted by the Senate and House of Representa-
 - 2 tives of the United States of America in Congress assembled,

3 SECTION 1. SHORT TITLE.

- 4 This Act may be cited as the "Public Health Pre-
- 5 paredness Workforce Development Act of 2005".

1 SEC. 2. FINDINGS.

2 Congress makes the following findings:

3 (1) The ability of the public health system to 4 prevent, respond to, and recover from bioterrorism 5 or acute outbreaks of infectious diseases and other 6 health threats and emergencies depends upon the ex-7 istence of adequate numbers of well-trained public 8 health professionals in Federal, State, local, and 9 tribal public health departments. The public health 10 system has an aging staff nearing retirement with 11 no clear pipeline of highly-skilled and capable em-12 ployees to fill the void. The average age of the State 13 public health workforce is 47, 7 years older than the 14 average age of the nation's workforce. More than 50 15 percent of the States cite the lack of qualified indi-16 viduals or individuals willing to relocate as being a 17 major barrier to preparedness.

(2) The National Association of State Personnel
Executives reports that State governments could lose
more than 30 percent of their workforce to retirement, private-sector employers, and alternative careers by 2006. The rates for State public health departments are as high as 45 percent.

(3) The ratio of public health workers to the
population has dropped from 219 per 100,000 in
1980 to 158 per 100,000 in 2000.

(4) Approximately 42 percent of the current ep idemiology workforce in State and territorial health
 departments lacks formal academic training in epi demiology.

5 (5) Thirteen State public health laboratories
6 are without doctoral-level molecular scientists on
7 staff, 23 have only one, and only 15 States have any
8 staff redundancy at this level.

9 (6) Public health nurses comprise the largest
10 segment of the public health workforce. The leaders
11 of State public health nursing average more than 30
12 years service and are very close to retirement. In one
13 State nearly 40 percent of the public health nursing
14 workforce is eligible for retirement today.

(7) Nearly half of the Federal employees in occupations critical to United States biodefense will be
eligible to retire within the next 5 years. The high
number of employees nearing retirement is accompanied by alarmingly small numbers of younger employees doing biodefense work for the Federal government.

(8) The Partnership for Public Service reports
that in the field of microbiology, there are four times
as many employees over age 40 as under age 40 at
the Centers for Disease Control and Prevention.

1 Among employees with medical backgrounds at the 2 Centers for Disease Control and Prevention and the 3 Food and Drug Administration, there are more than 4 twice as many employees over 40 years of age as 5 under 40. 6 (9) Bureau of Labor Statistics data project that 7 the demand for physicians and related occupations is 8 expected to be 26 percent greater in 2012 than 9 2002, but the number of medical professionals enter-10 ing the labor market has remained generally con-11 stant over the last 20 years. 12 SEC. 3. PUBLIC HEALTH WORKFORCE SCHOLARSHIP AND 13 LOAN REPAYMENT PROGRAM. 14 Part E of title VII of the Public Health Service Act 15 (42 U.S.C. 294n et seq.) is amended by adding at the end the following: 16 17 "Subpart 3—Public Health Workforce Scholarship 18 and Loan Repayment Program 19 "SEC. 780. PUBLIC HEALTH WORKFORCE SCHOLARSHIP 20 PROGRAM. "(a) ESTABLISHMENT.—The Secretary shall estab-21 22 lish the Public Health Workforce Scholarship Program 23 (referred to in this section as the 'Program') to assure 24 an adequate supply of public health professionals to elimi-

25 nate critical public health preparedness workforce short-

1 ages in Federal, State, local, and tribal public health agen-2 cies. 3 "(b) ELIGIBILITY.—To be eligible to participate in 4 the Program, an individual shall— 5 "(1) be accepted for enrollment, or be enrolled, 6 as a full-time student— "(A) in an accredited (as determined by 7 8 the Secretary) educational institution in a State 9 or territory; and "(B) in a course of study or program, of-10 11 fered by such institution and approved by the 12 Secretary, leading to a health professions de-13 gree (graduate, undergraduate, or associate) or 14 certificate, which may include laboratory 15 sciences, epidemiology, environmental health, 16 health communications, health education and 17 behavioral sciences, information sciences, or 18 public administration; 19 "(2) be a United States citizen; "(3) submit an application to the Secretary to 20 21 participate in the Program; and "(4) sign and submit to the Secretary, at the 22 23 time of the submittal of such application, a written 24 contract (described in subsection (d)) to serve, upon 25 the completion of the course of study or program

1	involved, for the applicable period of obligated serv-
2	ice in the full-time employment of a Federal, State,
3	local, or tribal public health agency.
4	"(c) Dissemination of Information.—
5	"(1) Application and contract forms.—
6	The Secretary shall disseminate application forms
7	and contract forms to individuals desiring to partici-
8	pate in the Program. The Secretary shall include
9	with such forms—
10	"(A) a fair summary of the rights and li-
11	abilities of an individual whose application is
12	approved (and whose contract is accepted) by
13	the Secretary, including in the summary a clear
14	explanation of the damages to which the United
15	States is entitled to recover in the case of the
16	individual's breach of the contract; and
17	"(B) information relating to the service ob-
18	ligation and such other information as may be
19	necessary for the individual to understand the
20	individual's prospective participation in the Pro-
21	gram.
22	"(2) INFORMATION FOR SCHOOLS.—The Sec-
23	retary shall distribute to health professions schools
24	and other appropriate accredited academic institu-
25	tions and relevant Federal, State, local, and tribal

1	public health agencies, materials providing informa-
2	tion on the Program and shall encourage such
3	schools, institutions, and agencies to disseminate
4	such materials to potentially eligible students.
5	"(3) UNDERSTANDABILITY AND TIMING.—The
6	application form, contract form, and all other infor-
7	mation furnished by the Secretary under this section
8	shall—
9	"(A) be written in a manner calculated to
10	be understood by the average individual apply-
11	ing to participate in the Program; and
12	"(B) be made available by the Secretary on
13	a date sufficiently early to ensure that such in-
14	dividuals have adequate time to carefully review
15	and evaluate such forms and information.
16	"(d) CONTRACT.—The written contract (referred to
17	in this section) between the Secretary and an individual
18	shall contain—
19	"(1) an agreement on the part of the Secretary
20	that the Secretary will provide the individual with a
21	scholarship for a period of years (not to exceed 4
22	academic years) during which the individual shall
23	pursue an approved course of study or program to
24	prepare the individual to serve in the public health
25	workforce;

1	((2) an agreement on the part of the individual
2	that the individual will—
3	"(A) maintain full-time enrollment in the
4	approved course of study or program described
5	in subsection $(b)(1)$ until the individual com-
6	pletes that course of study or program;
7	"(B) while enrolled in the course of study
8	or program, maintain an acceptable level of aca-
9	demic standing (as determined under regula-
10	tions of the Secretary by the educational insti-
11	tution offering such course of study or pro-
12	gram); and
13	"(C) immediately upon graduation, serve
14	in the full-time employment of a Federal, State,
15	local, or tribal public health agency in a posi-
16	tion related to the course of study or program
17	for which the contract was awarded for a period
18	of time (referred to in this section as the 'pe-
19	riod of obligated service') equal to the greater
20	of—
21	"(i) 1 year for each academic year for
22	which the individual was provided a schol-
23	arship under the Program; or

24 "(ii) 2 years;

1	"(3) an agreement by both parties as to the na-
2	ture and extent of the scholarship assistance, which
3	may include—
4	"(A) payment of the tuition expenses of
5	the individual;
6	"(B) payment of all other reasonable edu-
7	cational expenses of the individual including
8	fees, books, equipment and laboratory expenses;
9	and
10	"(C) payment of a stipend of not more
11	than $$1,200$ per month for each month of the
12	academic year involved (indexed to account for
13	increases in the Consumer Price Index); and
14	"(4) a provision that any financial obligation of
15	the United States arising out of a contract entered
16	into under this section and any obligation of the in-
17	dividual which is conditioned thereon, is contingent
18	upon funds being appropriated for scholarships
19	under this section;
20	((5) a statement of the damages to which the
21	United States is entitled for the individual's breach
22	of the contract; and
23	"(6) such other statements of the rights and li-
24	abilities of the Secretary and of the individual, not
25	inconsistent with the provisions of this section.

"(e) Postponing Obligated Service.—With re-1 2 spect to an individual receiving a degree or certificate from 3 a school of medicine, public health, nursing, osteopathic 4 medicine, dentistry, veterinary medicine, optometry, po-5 diatry, pharmacy, psychology, or social work under a 6 scholarship under the Program, the date of the initiation 7 of the period of obligated service may be postponed, upon 8 the submission by the individual of a petition for such 9 postponement and approval by the Secretary, to the date 10 on which the individual completes an approved internship, 11 residency, or other relevant public health preparedness ad-12 vanced training program.

13 "(f) Administrative Provisions.—

"(1) CONTRACTS WITH INSTITUTIONS.—The
Secretary may contract with an educational institution in which a participant in the Program is enrolled, for the payment to the educational institution
of the amounts of tuition and other reasonable educational expenses described in subsection (d)(3).

20 "(2) EMPLOYMENT CEILINGS.—Notwith21 standing any other provision of law, individuals who
22 have entered into written contracts with the Sec23 retary under this section, while undergoing academic
24 training, shall not be counted against any employ-

ment ceiling affecting the Department or any other
 Federal agency.

3 "(g) BREACH OF CONTRACT.—An individual who
4 fails to comply with the contract entered into under sub5 section (d) shall be subject to the same financial penalties
6 as provided for under section 338E for breaches of schol7 arship contracts under sections 338A.

8 "SEC. 781. PUBLIC HEALTH WORKFORCE LOAN REPAYMENT 9 PROGRAM.

10 "(a) ESTABLISHMENT.—The Secretary shall estab-11 lish the Public Health Workforce Loan Repayment Pro-12 gram (referred to in this section as the 'Program') to as-13 sure an adequate supply of public health professionals to 14 eliminate critical public health preparedness workforce 15 shortages in Federal, State, local, and tribal public health 16 agencies.

17 "(b) ELIGIBILITY.—To be eligible to participate in18 the Program, an individual shall—

19 "(1)(A) be accepted for enrollment, or be en-20 rolled, as a full-time or part-time student in an ac-21 credited academic educational institution in a State 22 or territory in the final year of a course of study or 23 program offered by that institution leading to a 24 health professions degree or certificate, which may 25 include a degree (graduate, undergraduate, or associate) or certificate relating to laboratory sciences,
 epidemiology, environmental health, health commu nications, health education and behavioral sciences,
 information sciences, or public administration; or

5 "(B) have graduated, within 10 years, from an 6 accredited educational institution in a State or terri-7 tory and received a health professions degree (grad-8 uate, undergraduate, or associate) or certificate, 9 which may include a degree (graduate, under-10 graduate, or associate) or certificate relating to lab-11 oratory sciences, epidemiology, environmental health, 12 health communications, health education and behav-13 ioral sciences, information sciences, or public admin-14 istration;

"(2)(A) in the case of an individual described in
paragraph (1)(A), have accepted employment with a
Federal, State, local, or tribal public health agency,
as recognized by the Secretary, to commence upon
graduation; or

"(B) in the case of an individual described in
paragraph (1)(B), be employed by, or have accepted
employment with, a Federal, State, local, or tribal
public health agency, as recognized by the Secretary;
"(3) be a United States citizen;

1	"(4) submit an application to the Secretary to
2	participate in the Program; and
3	"(5) sign and submit to the Secretary, at the
4	time of the submittal of such application, a written
5	contract (described in subsection (d)) to serve for
6	the applicable period of obligated service in the full-
7	time employment of a Federal, State, local, or tribal
8	public health agency.
9	"(c) Dissemination of Information.—
10	"(1) Application and contract forms.—
11	The Secretary shall disseminate application forms
12	and contract forms to individuals desiring to partici-
13	pate in the Program. The Secretary shall include
14	with such forms—
15	"(A) a fair summary of the rights and li-
16	abilities of an individual whose application is
17	approved (and whose contract is accepted) by
18	the Secretary, including in the summary a clear
19	explanation of the damages to which the United
20	States is entitled to recover in the case of the
21	individual's breach of the contract; and
22	"(B) information relating to the service ob-
23	ligation and such other information as may be
24	necessary for the individual to understand the

individual's prospective participation in the Program.

3 "(2) INFORMATION FOR SCHOOLS.—The Sec-4 retary shall distribute to health professions schools 5 and other appropriate accredited academic institu-6 tions and relevant Federal, State, local, and tribal 7 public health agencies, materials providing informa-8 tion on the Program and shall encourage such 9 schools, institutions, and agencies to disseminate 10 such materials to potentially eligible students.

"(3) UNDERSTANDABILITY AND TIMING.—The
application form, contract form, and all other information furnished by the Secretary under this section
shall—

15 "(A) be written in a manner calculated to
16 be understood by the average individual apply17 ing to participate in the Program; and

18 "(B) be made available by the Secretary on
19 a date sufficiently early to ensure that such in20 dividuals have adequate time to carefully review
21 and evaluate such forms and information.

22 "(d) CONTRACT.—The written contract (referred to
23 in this section) between the Secretary and an individual
24 shall contain—

1	"(1) an agreement on the part of the Secretary
2	that the Secretary will repay on behalf of the indi-
3	vidual loans incurred by the individual in the pursuit
4	of the relevant public health preparedness workforce
5	educational degree or certificate in accordance with
6	the terms of the contract;
7	((2) an agreement on the part of the individual
8	that the individual will serve, immediately upon
9	graduation in the case of an individual described in
10	subsection $(b)(1)(A)$ service, or in the case of an in-
11	dividual described in subsection $(b)(1)(B)$ continue
12	to serve, in the full-time employment of a Federal,
13	State, local, or tribal public health agency in a posi-
14	tion related to the course of study or program for
15	which the contract was awarded for a period of time
16	(referred to in this section as the 'period of obligated
17	service') equal to the greater of—
18	"(i) 3 years; or
19	"(ii) such longer period of time as de-
20	termined appropriate by the Secretary and
21	the individual;
22	((3) an agreement, as appropriate, on the part
23	of the individual to relocate for the entire period of
24	obligated service to a political jurisdiction designated
25	by the Secretary to be a priority service area in ex-

change for an additional loan repayment incentive
 amount that does not exceed 20 percent of the indi vidual's eligible loan repayment award per academic
 year such that the total of the loan repayment and
 the incentive amount shall not exceed 1/3 of the eligi ble loan balance per year;

"(4) in the case of an individual described in 7 8 subsection (b)(1)(A) who is in the final year of study 9 and who has accepted employment with a Federal, 10 State, local, or tribal public health agency upon 11 graduation, an agreement on the part of the indi-12 vidual to complete the education or training, main-13 tain an acceptable level of academic standing (as de-14 termined by the education institution offering the 15 course of study or training), and agree to the period 16 of obligated service;

"(5) a provision that any financial obligation of
the United States arising out of a contract entered
into under this section and any obligation of the individual that is conditioned thereon, is contingent on
funds being appropriated for loan repayments under
this section;

23 "(6) a statement of the damages to which the
24 United States is entitled, under this section for the
25 individual's breach of the contract; and

"(7) such other statements of the rights and li abilities of the Secretary and of the individual, not
 inconsistent with this section.

4 "(e) Payments.—

5 "(1) IN GENERAL.—A loan repayment provided for an individual under a written contract under the 6 7 Program shall consist of payment, in accordance 8 with paragraph (2), on behalf of the individual of 9 the principal, interest, and related expenses on gov-10 ernment and commercial loans received by the indi-11 vidual regarding the undergraduate or graduate edu-12 cation of the individual (or both), which loans were 13 made for—

14 "(A) tuition expenses; or

15 "(B) all other reasonable educational ex16 penses, including fees, books, and laboratory ex17 penses, incurred by the individual.

18 "(2) PAYMENTS FOR YEARS SERVED.—

"(A) IN GENERAL.—For each year of obligated service that an individual contracts to
gated service that an individual contracts to
serve under subsection (d) the Secretary may
pay up to \$35,000 on behalf of the individual
for loans described in paragraph (1). With respect to participants under the Program whose
total eligible loans are less than \$105,000, the

1	Secretary shall pay an amount that does not ex-
2	ceed $\frac{1}{3}$ of the eligible loan balance for each
3	year of obligated service of the individual.
4	"(B) Repayment schedule.—Any ar-
5	rangement made by the Secretary for the mak-
6	ing of loan repayments in accordance with this
7	subsection shall provide that any repayments
8	for a year of obligated service shall be made no
9	later than the end of the fiscal year in which
10	the individual completes such year of service.
11	"(3) TAX LIABILITY.—For the purpose of pro-
12	viding reimbursements for tax liability resulting
13	from payments under paragraph (2) on behalf of an
14	individual—
15	"(A) the Secretary shall, in addition to
16	such payments, make payments to the indi-
17	vidual in an amount not to exceed 39 percent
18	of the total amount of loan repayments made
19	for the taxable year involved; and
20	"(B) may make such additional payments
21	as the Secretary determines to be appropriate
22	with respect to such purpose.
23	"(4) PAYMENT SCHEDULE.—The Secretary
24	may enter into an agreement with the holder of any
25	loan for which payments are made under the Pro-

gram to establish a schedule for the making of such
 payments.

3 "(f) POSTPONING OBLIGATED SERVICE.—With re-4 spect to an individual receiving a degree or certificate from 5 a school of medicine, public health, nursing, osteopathic 6 medicine, dentistry, veterinary medicine, optometry, po-7 diatry, pharmacy, psychology, or social work, the date of 8 the initiation of the period of obligated service may be 9 postponed, upon the submission by the individual of a peti-10 tion for such postponement and approval by the Secretary, to the date on which the individual completes an approved 11 12 internship, residency, or other relevant public health pre-13 paredness advanced training program.

14 "(g) Administrative Provisions.—

15 "(1) HIRING PRIORITY.—Notwithstanding any 16 other provision of law, Federal, State, local, and 17 tribal public health agencies may give hiring priority 18 to any individual who has qualified for and is willing 19 to execute a contract to participate in the Program. 20 (2)CEILINGS.—Notwith-Employment 21 standing any other provision of law, individuals who 22 have entered into written contracts with the Sec-23 retary under this section, who are serving as full-24 time employees of a State, local, or tribal public 25 health agency, or who are in the last year of public health workforce academic preparation, shall not be
 counted against any employment ceiling affecting
 the Department or any other Federal agency.

4 "(h) BREACH OF CONTRACT.—An individual who
5 fails to comply with the contract entered into under sub6 section (d) shall be subject to the same financial penalties
7 as provided for under section 338E for breaches of loan
8 repayment contracts under section 338B.

9 "SEC. 782. GRANTS FOR STATE AND LOCAL PROGRAMS.

10 "(a) IN GENERAL.—For the purpose of operating 11 State, local, and tribal public health workforce loan repay-12 ment programs, the Secretary shall award a grant to any 13 public health agency that receives public health prepared-14 ness cooperative agreements, or other successor coopera-15 tive agreements, from the Department of Health and 16 Human Services.

"(b) REQUIREMENTS.—A State or local loan repayment program operated with a grant under subsection (a)
shall incorporate all provisions of the Public Health Workforce Loan Repayment Program under section 781, including the ability to designate priority service areas within the relevant political jurisdiction.

23 "(c) ADMINISTRATION.—The head of the State or24 local office that receives a grant under subsection (a) shall

be responsible for contracting and operating the loan re payment program under the grant.

3 "(d) RULE OF CONSTRUCTION.—Nothing in this sec4 tion shall be construed to obligate or limit any State, local,
5 or tribal government entity from implementing inde6 pendent or supplemental public health workforce develop7 ment programs within their borders.

8 "SEC. 783. CATALOGUE OF FEDERAL PUBLIC HEALTH 9 WORKFORCE EMPLOYMENT OPPORTUNITIES.

"(a) IN GENERAL.—The Director of the Office of
Personnel Management, in cooperation with the Secretary,
shall ensure that within the Office of Personnel Management's website, there is an on-line catalogue of public
health workforce employment opportunities in the Federal
Government.

16 "(b) REQUIREMENTS.—To the extent practical, the
17 catalogue described in subsection (a) shall include—

18 "(1) existing and projected job openings in the19 Federal public health workforce; and

20 "(2) a general discussion of the occupations21 that comprise the Federal public health workforce.

"(c) INFORMATION.—The Secretary shall include a
copy of the catalogue, or a prominent reference to the
catalogue, in—

"(1) the information for schools provided under
 section 780(c)(2) and 781(c)(2); and
 "(2) the application forms provided under sec-

4 tions 780(c)(1) and 781(c)(1).

5 "SEC. 784. AUTHORIZATION OF APPROPRIATIONS.

6 "(a) SCHOLARSHIP PROGRAM.—For the purpose of 7 carrying out section 780, there is authorized to be appro-8 priated \$35,000,000 for fiscal year 2006, and such sums 9 as may be necessary for each of fiscal years 2007 through 10 2011.

11 "(b) LOAN REPAYMENT PROGRAMS.—

"(1) IN GENERAL.—For the purpose of carrying out sections 781 and 782, there is authorized
to be appropriated \$195,000,000 for fiscal year
2006, and such sums as may be necessary for each
of fiscal years 2007 through 2011.

17 "(2) ALLOCATION.—Not less than 80 percent
18 of the amount appropriated under paragraph (1) in
19 each fiscal year shall be made available to carry out
20 section 782.

21 "SEC. 785. SEVERABILITY.

"If any provision of this subpart, or the applicationof such provision to any person or circumstance, is heldto be unconstitutional, the remainder of this subpart and

1 the application of the provisions of this subpart to any

2 person or circumstance shall not be affected thereby.".
