A BILL

To amend title 10, United States Code, to rename the death gratuity payable for deaths of members of the Armed Forces as fallen hero compensation, and for other purposes.

- 3 SECTION 1. RENAMING OF DEATH GRATUITY PAYABLE FOR
- 4 DEATHS OF MEMBERS OF THE ARMED
- 5 FORCES AS FALLEN HERO COMPENSATION.
- 6 (a) IN GENERAL.—Subchapter II of chapter 75 of
- 7 title 10, United States Code, is amended as follows:

1	(1) In section 1475(a), by striking "have a
2	death gratuity paid" and inserting "have fallen here
3	compensation paid".
4	(2) In section 1476(a)—
5	(A) in paragraph (1), by striking "a death
6	gratuity" and inserting "fallen hero compensa-
7	tion"; and
8	(B) in paragraph (2), by striking "A death
9	gratuity" and inserting "Fallen hero compensa-
10	tion".
11	(3) In section 1477(a), by striking "A death
12	gratuity" and inserting "Fallen hero compensation".
13	(4) In section 1478(a), by striking "The death
14	gratuity" and inserting "The amount of fallen here
15	compensation".
16	(5) In section 1479(1), by striking "the death
17	gratuity" and inserting "fallen hero compensation".
18	(6) In section 1489—
19	(A) in subsection (a), by striking "a gra-
20	tuity" in the matter preceding paragraph (1)
21	and inserting "fallen hero compensation"; and
22	(B) in subsection (b)(2), by inserting "or
23	other assistance" after "lesser death gratuity".
24	(b) CLERICAL AMENDMENTS.—(1) Such subchapter

- 12 shall be deemed to be a reference to fallen hero compensa-
- 13 tion payable under such subchapter, as amended by this
- 14 section.
