## A BILL

To designate a United States Anti-Doping Agency.

- Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled,

  SECTION 1. DESIGNATION OF UNITED STATES ANTIDOPING AGENCY.

  (a) DEFINITIONS.—In this Act:

  (1) UNITED STATES OLYMPIC COMMITTEE.—

  The term "United States Olympic Committee"
- means the organization established by the "Ted Stevens Olympic and Amateur Sports Act" (36 U.S.C. 220501 et seq.).

- (3) AMATEUR ATHLETE.—The term "amateur athlete" means an athlete who meets the eligibility standards established by the national governing body or paralympic sports organization for the sport in which the athlete competes (36 U.S.C. 22501(b)(1)).
- 11 (b) IN GENERAL.—The United States Anti-Doping12 Agency shall—
  - (1) serve as the independent anti-doping organization for the amateur athletic competitions recognized by the United States Olympic Committee;
  - (2) ensure that athletes participating in amateur athletic activities recognized by the United States Olympic Committee are prevented from using performance-enhancing drugs;
  - (3) implement anti-doping education, research, testing, and adjudication programs to prevent United States Amateur Athletes participating in any activity recognized by the United States Olympic Committee from using performance-enhancing drugs; and

1 (4) serve as the United States representative 2 responsible for coordination with other anti-doping 3 organizations coordinating amateur athletic competi-4 tions recognized by the United States Olympic Com-5 mittee to ensure the integrity of athletic competition, 6 the health of the athletes and the prevention of use 7 of performance-enhancing drugs by United States 8 amateur athletes. SEC. 2. RECORDS, AUDIT, AND REPORT. 10 Records.—The United States Anti-Doping Agency shall keep correct and complete records of account. 11 12 (b) Report.—The United States Anti-Doping Agen-13 cy shall submit an annual report to Congress which shall 14 include— 15 (1) an audit conducted and submitted in ac-16 cordance with section 10101 of title 36, United 17 States Code; and 18 (2) a description of the activities of the agency. 19 SEC. 3. AUTHORIZATION OF APPROPRIATIONS. 20 There are authorized to be appropriated to the 21 United States Anti-Doping Agency— 22 (1) for fiscal year 2006, \$9,500,000; 23 (2) for fiscal year 2007, \$9,900,000; 24 (3) for fiscal year 2008, \$10,500,000; 25 (4) for fiscal year 2009, \$10,800,000; and

1 (5) for fiscal year 2010, \$11,100,000.
