## A BILL

To amend the Reclamation Wastewater and Groundwater Study and Facilities Act to authorize the Secretary of the Interior to participate in the Inland Empire regional recycling project and in the Cucamonga Valley Water District recycling project.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. INLAND EMPIRE AND CUCAMONGA VALLEY RE-**  
4 **CYCLING PROJECTS.**

5 (a) SHORT TITLE.—This section may be cited as the  
6 “Inland Empire Regional Water Recycling Initiative”.

1 (b) IN GENERAL.—The Reclamation Wastewater and  
2 Groundwater Study and Facilities Act (43 U.S.C. 390h  
3 et seq.) is amended—

4 (1) by redesignating the second section 1636  
5 (as added by section 1(b) of Public Law 108–316  
6 (118 Stat. 1202)) as section 1637; and

7 (2) by adding at the end the following:

8 **“SEC. 1638. INLAND EMPIRE REGIONAL WATER RECYCLING**  
9 **PROJECT.**

10 “(a) IN GENERAL.—The Secretary, in cooperation  
11 with the Inland Empire Utilities Agency, may participate  
12 in the design, planning, and construction of the Inland  
13 Empire regional water recycling project described in the  
14 report submitted under section 1606(c).

15 “(b) COST SHARING.—The Federal share of the cost  
16 of the project described in subsection (a) shall not exceed  
17 25 percent of the total cost of the project.

18 “(c) LIMITATION.—Funds provided by the Secretary  
19 shall not be used for operation and maintenance of the  
20 project described in subsection (a).

21 “(d) AUTHORIZATION OF APPROPRIATIONS.—There  
22 is authorized to be appropriated to carry out this section  
23 \$20,000,000.

1 **“SEC. 1639. CUCAMONGA VALLEY WATER RECYCLING**  
2 **PROJECT.**

3 “(a) IN GENERAL.—The Secretary, in cooperation  
4 with the Cucamonga Valley Water District, may partici-  
5 pate in the design, planning, and construction of the  
6 Cucamonga Valley Water District satellite recycling plants  
7 in Rancho Cucamonga, California, to reclaim and recycle  
8 approximately 2 million gallons per day of domestic waste-  
9 water.

10 “(b) COST SHARING.—The Federal share of the cost  
11 of the project described in subsection (a) shall not exceed  
12 25 percent of the capital cost of the project.

13 “(c) LIMITATION.—Funds provided by the Secretary  
14 shall not be used for operation and maintenance of the  
15 project described in subsection (a).

16 “(d) AUTHORIZATION OF APPROPRIATIONS.—There  
17 is authorized to be appropriated to carry out this section,  
18 \$10,000,000.”.

19 (e) CONFORMING AMENDMENTS.—The table of sec-  
20 tions in section 2 of the Reclamation Projects Authoriza-  
21 tion and Adjustment Act of 1992 (43 U.S.C. prec. 371)  
22 is amended by striking the item relating to the second sec-  
23 tion 1636 (as added by section 2 of Public Law 108–316  
24 (118 Stat. 1202)) and inserting the following:

“Sec. 1637. Williamson County, Texas, Water Recycling and Reuse Project.

“Sec. 1638. Inland Empire Regional Water Recycling Program.  
“Sec. 1639. Cucamonga Valley Water Recycling Project.”.
