Mr. REID (for himself and Mr. ENSIGN) introduced the following bill; which was read twice and referred to the Committee on Energy and Natural Resources

A BILL

To provide for the release of certain land from the Sunrise Mountain Instant Study Area in the State of Nevada and to grant a right-of-way across the released land for the construction and maintenance of a flood control project.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Orchard Detention
5 Basin Flood Control Act”.

6 **SEC. 2. DEFINITIONS.**

7 In this Act:

1 (1) COUNTY.—The term “County” means Clark
2 County, Nevada.

3 (2) MAP.—The term “map” means the map en-
4 titled “Orchard Detention Basin” and dated March
5 18, 2005.

6 (3) SECRETARY.—The term “Secretary” means
7 the Secretary of the Interior.

8 **SEC. 3. RELEASE OF CERTAIN LAND IN THE SUNRISE**
9 **MOUNTAIN INSTANT STUDY AREA.**

10 (a) FINDING.—Congress finds that the land de-
11 scribed in subsection (c) has been adequately studied for
12 wilderness designation under section 603 of the Federal
13 Land Policy and Management Act of 1976 (43 U.S.C.
14 1782).

15 (b) RELEASE.—The land described in subsection
16 (c)—

17 (1) is no longer subject to section 603(c) of the
18 Federal Land Policy and Management Act of 1976
19 (43 U.S.C. 1782(c)); and

20 (2) shall be managed in accordance with—

21 (A) land management plans adopted under
22 section 202 of that Act (43 U.S.C. 1712); and

23 (B) cooperative conservation agreements in
24 existence on the date of enactment of this Act.

1 (c) DESCRIPTION OF LAND.—The land referred to in
2 subsections (a) and (b) is the approximately 65 acres of
3 land in the Sunrise Mountain Instant Study Area of the
4 County that is—

5 (1) known as the “Orchard Detention Basin”;

6 and

7 (2) designated for release on the map.

8 (d) RIGHT-OF-WAY.—The Secretary shall grant to
9 the County a right-of-way to the land described in sub-
10 section (c) for the construction and maintenance of the
11 Orchard Detention Basin Project on the land.
