- 16 Under Current Waivers.—In the case of any waiver,

- 18 allow funds made available under title XXI of the Social

- 20 vide child health assistance or other health benefits cov-
- 21 erage to an adult (other than pregnant adult) that is ap-
- 22 proved as of the date of the enactment of this Act, on
- 23 and after such date the Secretary of Health and Human
- 24 Services shall not extend or renew such a waiver or project
- 25 in a manner that permits funds under the waiver or
