**AN ACT**

To direct the Secretary of the Interior to conduct a special resources study regarding the suitability and feasibility of designating certain historic buildings and areas in Taunton, Massachusetts, as a unit of the National Park System, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “Taunton, Massachu-  
5       setts Special Resources Study Act”.

1 **SEC. 2. FINDINGS.**

2 Congress finds the following:

3 (1) The city of Taunton, Massachusetts, is  
4 home to 9 distinct historic districts, with more than  
5 600 properties on the National Register of Historic  
6 Places. Included among these districts are the  
7 Church Green Historic District, the Courthouse His-  
8 toric District, the Taunton Green Historic District,  
9 and the Reed and Barton Historic District.

10 (2) All of these districts include buildings and  
11 building facades of great historical, cultural, and ar-  
12 chitectural value.

13 (3) Taunton Green is the site where the Sons  
14 of Liberty first raised the Liberty and Union Flag  
15 in 1774, an event that helped to spark a popular  
16 movement, culminating in the American Revolution,  
17 and Taunton citizens have been among the first to  
18 volunteer for America's subsequent wars.

19 (4) Robert Treat Paine, a citizen of Taunton,  
20 and the first Attorney General of Massachusetts,  
21 was a signer of the Declaration of Independence.

22 (5) Taunton was a leading community in the  
23 Industrial Revolution, and its industrial area has  
24 been the site of many innovations in such industries  
25 as silver manufacture, paper manufacture, and ship  
26 building.

1           (6) The landscaping of the Courthouse Green  
2           was designed by Frederick Law Olmsted, who also  
3           left landscaping ideas and plans for other areas in  
4           the city which have great value and interest as his-  
5           torical archives and objects of future study.

6           (7) Main Street, which connects many of the  
7           historic districts, is home to the Taunton City Hall  
8           and the Leonard Block building, 2 outstanding ex-  
9           amples of early 19th Century American architecture,  
10          as well as many other historically and architecturally  
11          significant structures.

12          (8) The city and people of Taunton have pre-  
13          served many artifacts, gravesites, and important  
14          documents dating back to 1638 when Taunton was  
15          founded.

16          (9) Taunton was and continues to be an impor-  
17          tant destination for immigrants from Europe and  
18          other parts of the world who have helped to give  
19          Southeastern Massachusetts its unique ethnic char-  
20          acter.

21 **SEC. 3. STUDY.**

22          The Secretary, in consultation with the appropriate  
23          State historic preservation officers, State historical soci-  
24          eties, the city of Taunton, and other appropriate organiza-  
25          tions, shall conduct a special resources study regarding the

1 suitability and feasibility of designating certain historic  
2 buildings and areas in Taunton, Massachusetts, as a unit  
3 of the National Park System. The study shall be con-  
4 ducted and completed in accordance with section 8(e) of  
5 Public Law 91–383 (16 U.S.C. 1a–5(e)) and shall include  
6 analysis, documentation, and determinations regarding  
7 whether the historic areas in Taunton—

8           (1) can be managed, curated, interpreted, re-  
9           stored, preserved, and presented as an organic whole  
10          under management by the National Park Service or  
11          under an alternative management structure;

12          (2) have an assemblage of natural, historic, and  
13          cultural resources that together represent distinctive  
14          aspects of American heritage worthy of recognition,  
15          conservation, interpretation, and continuing use;

16          (3) reflect traditions, customs, beliefs, and his-  
17          torical events that are valuable parts of the national  
18          story;

19          (4) provide outstanding opportunities to con-  
20          serve natural, historic, cultural, architectural, or sce-  
21          nic features;

22          (5) provide outstanding recreational and edu-  
23          cational opportunities; and

24          (6) can be managed by the National Park Serv-  
25          ice in partnership with residents, business interests,

1 nonprofit organizations, and State and local govern-  
2 ments to develop a unit of the National Park System  
3 consistent with State and local economic activity.

4 **SEC. 4. REPORT.**

5 Not later than 3 fiscal years after the date on which  
6 funds are first made available for this Act, the Secretary  
7 shall submit to the Committee on Natural Resources of  
8 the House of Representatives and the Committee on En-  
9 ergy and Natural Resources of the Senate a report on the  
10 findings, conclusions, and recommendations of the study  
11 required under section 3.

12 **SEC. 5. PRIVATE PROPERTY.**

13 The recommendations in the report submitted pursu-  
14 ant to section 4 shall include discussion and consideration  
15 of the concerns expressed by private landowners with re-  
16 spect to designating certain structures referred to in this  
17 Act as a unit of the National Park System.
